Then the House made Shroves of Richard Dallam for their Clerk Ordered that Mr Nathaniel Dars and Mr Philomon Homersly go with the Clerk and present him to his Excellency for Approbation and to see him qualified if approved They return and say they saw the Clerk qualified by taking the usual Oaths his Excellency having approved of him

Then the House adjourned till to Morrow Morning Tuesday 19th November 1708 The House met according to Adjournment being called over there appeared in the House the several Members following viz^t
