The several Committees appointed last Session, are continued.  
*James Holliday*, and *William Stoughton*, Esqrs; are sent to the Upper House, to see Col. *William Ennalls*, a Member returned to serve for *Dorchester* County, qualify'd: They return, and say they saw the same done.

Mr. *Peter Taylor*, a Representative of *Dorchester* County, appears in the House this Day.

*Order'd*, That a Warrant be issu'd to the Secretary, to prepare a new Writ of Election, to be directed to the Sheriff of *Prince George's* County, to elect a new Member, in the Place of Major *Samuel Perrie*, lately deceas'd.

This House adjourn'd until Two of the Clock in the Afternoon.
