RESOLVED, That this House will not receive the Petition for the Discharge of any Prisoner for Debt, unless Notice be given of such Prisoner's Intention to apply for Relief, by Advertisement set up at the Court-House Door, and in the Clerk's Office of the County where such Prisoner is confined, for the Space of Thirty Days at least before the Meeting of that Session of Assembly to which such Petition shall be preferred; and such Notice to be certified by the Justices of the County Court where such Prisoner is confined, or Three of the said Justices at the least.

ORDERED, That the following Resolve, made the 22^d Day of November 1763, be Entered on the Journal of this Session, and Printed with the foregoing Resolve, in the *Maryland Gazette.*

RESOLVED, That for the future this House will not take into Consideration any Petition from the Inhabitants of any County or Parish, relative to the imposing any kind of Taxes, or erecting any Public Buildings, or other Matter any way respecting the general Interest of such County or Parish, or particular Interest of any Part thereof, unless it shall be made appear, that Two Months at least before the offering such Petition to any Person to be subscribed, Advertisements were set up at all the Churches, Chapels, and Court-House of the said County, notifying the Intention of offering such Petition to be subscribed, in order to be preferred to this House.
