Mr. Grabame brings in, and delivers to *Mr. Speaker*, the following Report, viz.

By the COMMITTEE appointed by the Honourable the Lower House of Assembly, to Enquire and Report what Laws will Expire with the Close of this Session.

YOUR Committee, in pursuance of the Order and Direction of the Honourable House, have enquired, and do find that the following Laws will Expire at the End of this Session :

An Act continuing an Act, entitled, *An Act for Relieving the Inhabitants of this Province from some Aggrievances in the Prosecution of Suits at Law*, and for continuing the Supplementary Act thereto.

An Act continuing an Act, entitled, *An Act to remedy some Evils relating to Servants.*

An Act continuing an Act, entitled, *A Supplementary Act to the Act, entitled, An Act ascertaining the Height of Fences, to prevent the Evil occasioned by the Multitude of Horses, and restraining Horse-Rangers within this Province; and to redress the great Evil accruing to this Province, by the Multiplicity of useles Horses, Mares, and Colts, that run in the Woods.*

An Act continuing an Act, entitled, *An Act for the Gauge of Barrels for Pork, Beef, Pitch, Tar, Turpentine, and Tare of Barrels for Flour or Bread.*

An Act for Imposing an Additional Duty of Two Pounds per Poll on all Negroes imported into this Province.

An Act for the speedy Recovery of Small Debts out of Court, before One Justice of the Peace.
