

at the time of his election, possessed of property within the state above the value of £. 500 current money, as required by the constitution and form of government of this state, report, that from an account laid before the committee, and signed by the collector of the taxes in Harford county, it appears, that the assessable property of said John Montgomery in the county aforesaid is estimated to the value of sixty-five pounds current money; but your committee do not deem the said account conclusive evidence as to the value of said Montgomery's property, or a just criterion by which the house can decide on a case of this nature. Your committee further report, that a schedule of property, amounting to the sum required by the constitution and form of government, and verified by the oath of the said John Montgomery, has been laid before them, from which they are of opinion, that the said John Montgomery was eligible as a delegate for Harford county, and therefore entitled to keep his seat in this house.
