THE committee to whom was referred the memorial of Robert Amos, of Harford county, report, that they have taken the same into consideration, and are of opinion that the case merits the interference of the legislature in his behalf, but, from the complicated nature of his case, your committee are of opinion that an investigation of the subject would take up more time of the house than could reasonably be expected thereon at this late period of the session, therefore beg leave to suggest the propriety of the following resolution:

RESOLVED, That the memorial of Robert Amos, collector of the taxes in Harford county for the years 1783 and 1785, together with the papers relative thereto, be referred to the consideration of the chancellor, who is hereby authorized to determine finally on the same; and that the treasurer of the western shore pay to the said Amos, or his assigns, the sum of money the chancellor may decree in his favour, as due from the state of Maryland.
