Mercer, delegates returned for Anne-Arundel county, Mr. Thomas Par-ran and Mr. Thomas Blake, delegates returned for Calvert county, Mr. Samuel Jones, a delegate returned for Charles county, Mr. Thomas Love, a delegate returned for Baltimore county, Mr. Thomas S. Denny and Mr. John Edmondson, delegates returned for Talbot county, Mr. Solomon Frazier, Mr. Isaac Steele and Mr. Richard Goldsborough, delegates returned for Dorchester county, Mr. Richard Cramphin, a delegate returned for Prince-George's county, Mr. John Gunby and Mr. Ephraim King Wilson, delegates returned for Worcester county, Mr. Robert Orrell and Mr. Philip Clarke, delegates returned for Caroline county, Mr. John Cellar and Mr. Robert Smith, delegates returned for Washington county, Mr. Joseph Crefap, Mr. James Crefap, of Michael, and Mr. John Simkins, delegates returned for Allegany county, and Mr. Hezekiah Veach, a delegate returned for Montgomery county, appeared, and after qualifying in the mode prescribed by the constitution and form of government, and taking the oath to support the constitution of the United States, took their seats in the house.

The house proceeded to ballot for a speaker, and the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after some time returned and reported, that Edward Hall, Esquire, was unanimously elected.
