And be it enacted, That James M'Culloch, Thomas Hellen, Tobias E. Stansbury, major Thomas Talbot, Moses Brown, George Luckey, Hugh Whiteford, junior, doctor John Hall, Elijah Davis and John Moore, shall be and are hereby appointed trustees for the purpose of locating, erecting and superintending, the academy aforesaid, and it shall be lawful for them, or a majority of them, so soon as the said academy shall be fit for the reception of scholars, to draw on the treasurer of the western shore for the sum of eight hundred dollars annually, for the payment of the teacher or teachers of said academy, and a majority of the trustees hereby appointed shall be competent to perform any or all of the duties directed by this section."
