- No. 69. An ACT authorising a lottery to raise a sum of money to purchase a fire engine, and to purchase ground and build a school-house, in Rockville, in Montgomery county.
- No. 70. An ACT to authorise a lottery in Frederick-town, in Frederick county.
- No. 71. An ACT to authorise a lottery to raise a sum of money for building a bridge over a branch of Patuxent river at or near the mill of John Crow.
- No. 72. An ACT authorising a lottery to raise a sum of money for the purpose of rebuilding the steeple of the German reformed church in Frederick-town, in Frederick county.
