The bill for the relief and benefit of John Latour, of the city of Baltimore, the bill to repeal all such parts of the acts of assembly of this state as require the payment of twenty-five shillings for a marriage license, the bill authorising the levy court of Washington county to levy a sum of money for the purpose therein mentioned, the supplement to an act, entitled, An act to enlarge the powers of the trustees of the poor in the several counties therein designated, and the resolutions for the encouragement of domestic manufactures, were sent to the senate.

On motion by Mr. C. Dorsey, Leave given to bring in a bill, entitled, An act to incorporate the members and trustees of the Roman Catholic congregation worshipping at the Roman Catholic church near New-Port, Charles county. ORDERED, That Mr. C. Dorsey, Mr. Chapman and Mr. Stuart, be a committee to prepare and bring in the same.

The supplement to an act, entitled, An act to lay out a certain road in Baltimore county, was read the second time and passed.

On motion by Mr. Herbert, Leave given to bring in a bill, entitled, A supplement to an act, entitled, An act for the establishment of vestries for each parish in this state. ORDERED, That Mr. Herbert, Mr. Magruder, Mr. J. Brown, Mr. C. Dorsey and Mr. Calvert, be a committee to prepare and bring in the same.

On motion by Mr. Streett, the following order was read.

ORDERED, That this house will sit the remainder of the session from nine o'clock till two, and from four till eight, for the dispatch of public business.
