DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>Located about two miles southwest of Flintstone, the house stands on the northwesterly side of Murleys Branch Road between Breakneck and Dickerson Roads in Allegany County, Maryland.</p> <p>The Riggleman - McElfish House is a one story wooden structure with irregular size clapboard siding, a gable roof which extends over the one story porch that stretches across the front, recent masonry chimneys, and tin roofing. The house sets on top of a hill along the road and is screened by a series of pine trees and shrubs. The facade is asymmetrical with four windows and two doorways. The overall shape of the structure indicates that the house may have been originally erected as multi-residential. The principal windows have narrow frames with six-over-six lights in the double hung wooden sashes, characteristic of mid nineteenth century architecture of the area. The eaves have small scroll-cut barge boards, probably of the later nineteenth century.</p>

STATEMENT OF SIGNIFICANCE			
<p>This house, which appears to date from the early-mid nineteenth century, is identified in the September, 1972 issue of <u>Heritage Press</u> as the "Thomas McElfish Log Mansion."¹ (vol. 1, no. 11, p. 5) According to this publication of the Preservation Society of Allegany County, the house was built for Thomas McElfish, a member of one of the early settler families of the Flintstone area. The building is typical of the domestic architecture of the early-mid nineteenth century in Allegany County.</p>



DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Riggleman House is located on the northwest side of Murley's Branch Road, between Breakneck and Dickerson Roads, approximately two miles southwest of Flintstone, Allegany County.

The Riggleman House is one and a half stories, nine bay wide, rectangular block - covered with irregular size clapboard siding. The building rests on a high stone foundation. The tin roof is gabled and extends over the one story, partially enclosed porch that stretches across the front of the house. The principal windows have narrow frames with six over six lights in double hung wooden sashes. The facade is asymmetrical with four windows and two doorways, both of which are paneled and include the original hardware. Two chimneys, of recent masonry construction, are located at the inside gable ends of the house. The eaves have small scroll cut-barge boards, probably added in the late 19th century.

SPECIFIC DATES ca. 1850 BUILDER/ARCHITECT

STATEMENT OF SIGNIFICANCE

The Riggleman house was built around 1850 by Thomas McElfish, a member of one of the early settler families of the Flintstone area. The Heritage Press records the house as being originally owned by McElfish and son David, in a caption titled "Thomas McElfish Log Mansion." Although believed to be a log house by the Heritage Press, the house is actually a frame structure and is typical of the domestic architecture of the mid 19th century in Allegany County. The McElfish family operated a gun powder mill and a game chicken farm.

The house is in near original appearance and is a cultural reminder of a way of life once found in the rural Flintstone area.


