STATEMENT OF SIGNIFICANCE

See Ronald Andrews' description.

George (Tanner) Robinette, builder of the house, was the grandson of Capt. George Robinett. This property was inherited by George (Tanner) from his father Jesse Robinette (born June 15, 1776 died- November 26, 1832). In turn, Jesse Robinette was willed the property by his father, Capt. George Robinette in 1831. All thress are buried in the Green Meadow Cemetary.

Note: Deed: Liber T Folio 313 dated Aug. 5, 1837

John Piper, Jr. and Sally (his wife), James Robinette and Mariah (his wife), and John Davis, Jr. and Alice (his wife) deeded to George Robinette of Jesse. Real estate descended to above from Jesse Robinette, deceased, and also the dower interest of Dorcas Robinette, wife of said Jesse Robinette, deceased.

All the children of Jesse Robinette and his wife, Dorcas Johnson are buried in the Green Meadow Cemetary.

West Wilson Road, Flintstone
ca. 1845

The Patterson Barn is located on Break-neck Farm which consists of approximately 220 acres near Flintstone, Allegany County. The land on which the barn sits was purchased in 1843 by George Robinette, local farmer and tanner. The barn was probably constructed in 1845, the year Robinettes farm house was built. It is a large, two story, board and batten structure with a high stone foundation, gabled tin roof and six over six lights in the stone foundation.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Patterson Barn is located on the West Wilson Road, 1.5 miles southwest of the intersection of Dickerson Road.

The barn is a large two story, board and batten structure with a high stone foundation. The roof is gabled and covered with tin. Louvered ventilators are located near the roof line. Joists are visible near the girt on the west gable end. Windows with six over six lights are located in the stone foundation which is covered on one side by an overhang from the second story and supported by wooden posts with replaced block pilings.

STATEMENT OF SIGNIFICANCE

The Patterson Barn is located on Breakneck Farm which consists of approximately 220 acres near Flintstone, Allegany County. The land on which the barn sits was purchased in 1843 by George Robinette, local farmer and tanner. The barn was probably constructed in 1845, the year Robinette's farm house was built. The farm remained with the Robinettes until 1892 when it was sold to the Wilson family, whose primary interest was also farming. The Wilsons owned the property for another fifty years. Thus, the barn was probably in continuous use until 1942.¹


