first half 1800's

The Original owner of this house and farm was Thomas Cheney. This log house was most likely built before his death in 1850. Cheney's three sons split the farm after his death, and eventually, his grandson, Millard Cheney, owned the farm property. This log house is built with "V" notching of the logs, a typical construction in Allegany County where logs served as a functional building material because of the abundant forests. Cheney Log House serves as a reminder of a county-wide building practice and of a prominent 19th century farming family.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Cheney Log House stands on the west of what probably is part of the Old Hancock Road north of Flintstone Creek.

This house consists of a two story, three bays wide log structure with "V" notching. The southern facade is covered with weatherboard. It rests on a high foundation of random rubble stone with a plain water table. The gable flank roof is covered with ribbed tin. Eaves consist of a cornice and fascia. An original brick chimney located outside end of the original has been enclosed by an addition.

The main entrance in the center of the eastern facade has a replaced door. Six over six lights windows are pegged. A two story, two bays wide frame addition with german siding abuts the original on the north. It rests on a random ashlar stone foundation. The gable flank roof, with ribbed tin is extended to the west to form a saltbox. A shed roofed veranda is on the east and north of the addition. A log out building has square notching and a high random ashlar stone foundation.

STATEMENT OF SIGNIFICANCE

The Cheney farm property was originally owned by Thomas Cheney. This log house was probably built during Thomas Cheney's lifetime, before 1850, which is the year he died.⁽¹⁾ When Thomas died, his sons, John, Leonard, and Salathiel Cheney split up the farm.

A deed in 1870 mentions the "Cheney dwelling house."⁽²⁾ This deed also mentions that the Cheney's sold one acre of their land to John Piper to use as a "shanty for the sale of distilled spirits commonly known as grog hop."⁽³⁾ The Cheney's specify in the deed that they want no "indecent or angry language" spoken at the shanty.⁽⁴⁾

In 1902, Millard Cheney bought this part of the Cheney farm from Robert H. Gordon, Trustee for Equity 5105⁽⁵⁾. Millard was the son of Leonard Cheney. Equity Case 5105 mentions two dwelling houses on the property;⁽⁶⁾ One of them was this log house and the other one was Cheney Frame House (AL-11-A-120), already owned by Millard Cheney.

Logs were a very functional type of building material in Allegany County where forests are abundant. This house stands as a reminder of a county-wide building practice and a prominent 19th century farming family.


