The Long Farm House is a five bay wide, rectangular, brick structure with American Common Bond construction, a gabled roof, stone foundation and four over four lights. At one time, the Long House was the center of one of the largest working farms in the county comprising 1732 acres. In addition to the main house are several outbuildings including a tenant house and a combination smokehouse/wash house which are also of American Common Bond construction.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Long Farm House was built in 1861 to face the C & O Canal and is located just east of Oldtown, around 1 mile south of Route 51.

This two story, five bay wide structure is constructed of brick laid in American Common Bond. The block is "L" shaped and rests on a low stone foundation, featuring a beveled water table. A two story frame construct adjoins the brick on the northeastern corner. To that frame structure has been added a shed roofed semi-enclosed one story porch. On that same addition in the apex of the "L" lies an enclosed kitchen area downstairs with an enclosed bathroom directly above. Windows throughout the structure are double hung wooden sash frames with four over four lights with brick flat arches composed of stretchers stood on end. The main entrance on the south side features an original door of finely frilled woodwork outside and four verticle panels inside. There is a transom light above the door. Covering the entrance is an elegant three bay wide hipped roof front end porch, which is supported by six Roman Doric Columns with scrolled brackets on each capital. The roof over the main block is gabled with an asphalt shingle covering, and features soffit, frieze, and a Verge Board with pendant in the peak of each gable. Scrolled brackets with pendants are found where each gable end meets the horizontal eaves. There is small one bay hipped roof porch on the west side covering an entrance way. Featured are three original corbeled brick chimneys located on the inside end of each gable.

Just northeast of the farm house lies a one and a half story brick tenant house only one bay wide. It has a simple tin covered gabled roof with a central brick chimney. A semi-enclosed shed roofed porch was added to the front. Windows in this structure are unique to those found in the farmhouse; they have six over six lights and plain trim. A single sash four lights window is found in the front gable.

Twenty feet to the northwest of the tenant house lies a two story brick structure. The first floor was a wash-house with a smokehouse directly upstairs. It has six over six lights with the brick flat arch, as found in the farm house. There is an inside end brick chimney for meat smoking. The roof is gabled.

The Long Farm House stands structurally sound and is in fair condition. The original fabric, with the exception of new asphalt shingling, still remains.

STATEMENT OF SIGNIFICANCE

The Long Farm was at one time one of the largest working farms in Allegany County. At its peak of operation, 1732 acres were owned and farmed by the Long family. Actual crops grown included corn, and hay, which at harvest would amount from three to five thousand bales. Beef cattle were also raised there; the number of head would generally range from 100 to 150.

Thomas G. Long presently resides in the farm house. It was his grandfather, Isaac Long, who built the farm house in 1861. It was cleverly built on a small rise to face the Chesapeake and Ohio Canal. Some people believe the bricks used to construct the home were transported by boat on the C & O Canal. The house received a new roof after the Western Maryland Railroad was completed in the early 1900's. This action had to be taken due to flying debris caused by blasting, which damaged the Long's roof. In 1931, it was reported that the Long farm house was the first dwelling to receive electricity in their area.¹

The land was bought by Stegmaier Orchard Company in November of 1975, but Thomas Long retains the right to occupy the farm house. The Longs also retain the right to their family cemetery, which is located 150 yards west of the house. Isaac Long, the original builder, is buried there.¹


