The two story, rectangular shaped
Deffinbaugh Log House was constructed
upon 11 acres of ground around the 1850's.
Elegant styling was incorporated by the
Deffinbaugh family around the 1930's.
Novelty siding, shutters, a 28 light
morning window, screened-in porches,
and columns with scrolled brackets were
all added to the original house which
was then made twice as large with a
frame addition. It is presently used
as a summer vacation house.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Deffinbaugh Log House is situated along Town Creek Road approximately 5 miles north of Route 51.

The northern half of what is now a five bay wide frame structure was originally log. The present "L" shaped house stands two stories tall and rests on a low stone foundation. There is a one and a half story gabled roof frame addition on the northeast corner of the house, which abuts the original log section. Most windows in the structure are double hung wooden sash frames with two over two lights, cornices, architrave trim, and shutters. However, there is a new, large 28 light morning window on the northeast side of the house and one six over three light window on the rear second story of the original log section. Novelty siding now covers the entire structure. The front of the house has two entrances, both of which have replaced verticle paneled doors. A gabled roof covered with replaced asphalt materials shields the structure, and the gables have boxed cornices with returns. A soffit runs the perimeter of the house. There is a three bay end porch on the front of the house supported by square columns with scrolled brackets and covered by a hipped roof. The rear of the house features a four bay screened in porch with a hipped roof which adjoins the south side of the one and a half story rear addition. On the north side of that same addition lies a two bay screened in porch also having a hipped roof. There are two corbeled brick chimneys in the house, one centrally located and the other on the inside end of the south side.

The Deffinbaugh Log House has been favorably remodeled to greatly alter its original appearance of a two story rectangular, log cabin. It stands structurally sound and is in good condition.

STATEMENT OF SIGNIFICANCE

The Deffinbaugh House was constructed around the middle of the 19th century, as a two story, rectangular, log structure. It was an example of the typical log mansion built in the eastern half of Allegany County during that time period, being very similar to the Ruby Log and the McLaughlin Log. The Deffinbaugh family had control of the house and surrounding 11 acres until 1969. At the end of the first quarter of the 20th century, the house was elegantly refinished and enlarged; novelty siding, shutters and screened in porches were all added. The house is presently used as a summer vacation home.


