This house was built around 1845 when Greek Revival architecture was very popular. During the Civil War, when Cumberland was occupied by Union forces, the Sprigg family, who lived in this house and were Southern sympathizers, were forced to leave their home so that it could be used to house Union officers. This was common treatment of Southern sympathizers by Union forces. One of a group that comprises some of the oldest and most beautiful homes on Washington Street, this Greek Revival building features Flemish bond brick work on the main facade.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Sprigg House is located on Washington Street, Cumberland, Maryland.

The building basically consists of a two and one half story, two bay wide, rectangular shaped structure (originally square). Wall construction is brick, laid in american common bond using random variations, but mostly seven to one and eight to one. Flemish bond is featured on the southern facade. The building is supported by a high, stone foundation using uncoursed rubble bond that is now sheathed in tooled cement. It has a beveled water table. The roof of the building is gable flank covered with tin, replaced. It has gabled parapets with wooden caps sheathed with tin on the eastern and western facade. A brick cornice is featured on the eaves of the northern and southern facade. There are three brick chimneys in the house, two with corbeled caps which look original. One is located inside end, one is interior and one is central (no corbeling).

Building has a brick, two story wing on northern facade with hipped gable roof.

A one story, brick addition abuts the building on the western facade. It features a parapet with concrete capping and brick cornice with dentils. Its roof is covered with tar paper. It has two entrances. One is a two paneled, vertical board door with plain trim and brick drip moulding overhead. The other is a recessed basement door which is two paneled vertical boards with plain wooden trim. The three basement, recessed windows are fixed with six lights and plain wooden trim. This addition has a casement window with two, five light panes and swings out. It features a brick lugsill and brick drip label moulding. Four other casement windows are composed of two, eighteen light panes each, that swings out, with brick lugsills, brick drip label moulding with awning hooks.

The main entrance is located off-center on the southern facade with two wooden pilasters (one on each side) supporting a three part entablature with dentils. Tin flashing is exhibited over top of entablature. Leading up to the entrance is a concrete stoop porch with wrought iron railing. The door is recessed in a vestibule. (Vestibule has one tier of paneling on either side with two architrave panels each side.) The door is replaced, composed of vertical boards, architrave trim and two elongated rectangular lights with a plain glass transom overhead. It has one wooden pilaster on either side of door. The center of basement wall here indicates that either a door or window was once here but is now sealed shut with concrete blocks. The first floor windows on this facade are encased by four wooden pilasters (two serve as mullion) supporting a three part entablature with dentils topped with tin flashing. Along the base of the windows are plain trim panels. A very ornate wrought iron "balcony" railing is featured here.

## STATEMENT OF SIGNIFICANCE

201 Washington Street is an example of Cumberland's varied Greek Revival architectural style. An 1845 issue of the Alleghanian, a Cumberland newspaper, states that the Hazelhurst family had built a large and beautiful residence on Washington Street "within the past two years."<sup>1</sup> In 1844 M.E. Hazelhurst acquired the lot from Bean S. Pigman for four hundred dollars.<sup>2</sup> In 1857 she sold it to Maria Sprigg for twenty-five hundred dollars.<sup>3</sup> The difference between these two purchase prices **helps indicate that M.E. Hazelhurst built the house in either 1844 or 1845.**

Soon after the occupation of Cumberland by Union forces in 1861 the citizens felt the pressures of a Civil War as free speech was curtailed and secessionist sentiments were banned. Persons suspected of secessionist sympathies were arrested, lectured, and forced to give an oath of loyalty to the Union.<sup>4</sup> At times during the war, county citizens, usually those related to Confederate soldiers and suspected of passing information to them, were "exiled" from their homes.<sup>5</sup> A previous survey and local tradition both suggest that during the Civil War this was the case with the Sprigg family who were "taken into custody and forced to leave the house so that it might be used to house Union officers."<sup>6</sup>

The asymmetrical design of the two bay southern facade, when compared to other Greek Revival buildings built in the 1840's (See AL-IV-A-096 and AL-IV-A-106) tends to suggest that the Sprigg House was designed to be double on the western side at a later date. The heavy Greek Revival frames around both the off-center entrance and the window on the first floor of the southern facade have three part entablatures with dentils. The dentils on the cornice of the western addition are reflective of this motif.

An intriguing feature of the building is a blocked up aperture in the basement with an arched stone ceiling. This could be a wine or root cellar or, as local tradition suggests, a tunnel. Many properties on Washington Street contain "tunnels" and wells that allegedly are connected with the pre Revolutionary Fort Cumberland, but this is speculative and highly improbable.

Sprigg House stands prominently on the corner of Washington and Smallwood Streets. It enhances the Streetscape by preserving the continuum of Washington Street through the gap created by the recessed position of

There are three, double hung, six sash windows here. Two, two-over-two light windows; one on either side of one, six-over-six light window. Second floor has two, double hung, two sash, six-over-six light windows with flat brick arches and wooden lugsills. The second and one half floor features two gabled dormers with overhang, featuring two, double hung, two sash, two-over-two light windows with decorative moulding on sides.

The western facade has one, recessed basement window that is double hung, two sash, with three-over-three lights. First floor has one casement window, composed of two, one light panes that swings in. It features both a flat brick slipsill and flat brick arch. Second floor has two, double hung, two sash, four-over-four light windows with wooden lugsills. Also on this floor is an entrance to the parapet roof of the western addition. It is recessed with a two paneled vertical board door with three lights. Second and one half floor has one, double hung, two sash, six-over-six light window with wooden lugsill.

Eastern facade had two basement windows that are now sealed shut with concrete blocks. First floor has three, double hung, two sash, six-over-six light windows with flat brick arches, wooden lugsills and fixed louvered, wooden shutters. Second floor windows are identical to first floor except for some unused shutter hinges. Second and a half floor features two, double hung, two sash, two-over-two light windows with mullion. Both windows share the same flat brick arch and wooden lugsill with fixed louvered wooden shutters.

First floor has two, double hung, two sash, six-over-six light windows with flat brick arches. The one on the right as you face this facade is smaller with an exhaust fan mounted under the flat brick arch. This window has a wooden slipsill while the other has a wooden lugsill. Second floor has windows with same features as first floor with the window on the right, again being smaller with the wooden slipsill.

On the northwest corner is a porch with a flat roof. The parapet with brick cornice with dentils and concrete capping on the western addition, extends to cover top of porch. Porch is supported by two brick columns and pilaster with corbeled eaps under a brick lintel layed in a soldier course with awning hooks attached on western face.

Northern Facade -

First Floor - One double hung, two sash, 6/6 light, flat brick arch, wooden lugsill. One smaller window, with exhaust fan overhead, double hung, two sash, 6/6 light, flat brick arch, wooden slipsill.

Second Floor - One double hung, two sash, 6/6 light, flat brick arch, wooden lugsill. One smaller double hung, two sash, 6/6 light, flat brick arch, wooden slipsill.

Eastern Facade -

Basement - Two windows sealed shut with concrete blocks.

First Floor - Three double hung, two sash, 6/6 light, flat brick arches, wooden lugsills, fixed louvered, wooden shutters.

Second Floor - Three double hung, two sash, 6/6 light, flat brick arches, wooden lugsills, fixed louvered, wooden shutters, unused shutter hinges.

Second and a Half Floor - Two double hung, two sash, 2/2 light with mullion, sharing same flat brick arch and wooden lugsill. Fixed louvered, wooden shutters.

Western Facade -

Basement - One double hung, two sash, 3/3 light, recessed.

First Floor - One casement, two one light panes, swings in, flat brick slipsill, flat brick arch.

Second Floor - Entrance to parapet roof of addition, recessed, three lights, vertical boards, two panels, two double hung, two sash, 4/4 light, wooden lugsills.

Second and a Half Floor - One, 6/6 light, double hung, two sash, wooden lugsill.

Southern Facade - Basement - One door or window sealed shut with concrete blocks.

First Floor - Six sash, three double hung, two, 2/2 light one on either side of one, 6/6 light, three part entablature with dentils, two pilaster mullion and one on either side of windows, (4 in all) one plain trim panel below each window, very ornate wrought iron "balcony" railing. Both entrance and window entablature topped with tin flashing.

Second Floor - Two double hung, two sash, 6/6 light with flat brick arches, wooden lugsills.

Second and a Half Floor - Dormers. Two double hung, two sash, 2/2 light.

Basement - Three fixed, six lights, recessed, wooden trim.

Western Addition - Has parapet with brick cornice with dentils and concrete capping that extends over porch. Two entrances - One, two panels, vertical board door with plain trim, brick drip label moulding; one, recessed vertical board, two panel door with plain wooden trim. (Basement) One casement, two, five light panes swings out, brick lugsill, brick drip label moulding. Four casement, two eighteen light panes.

DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

201 Washington Street is an early Greek Revival town-house, with a deep and narrow plan, the narrow end facing the street. Built on a high stone base (which diminishes as it goes up the North Smallwood Street hill), the street facade is not the usual three bays (see 110 and 112 Washington Street) but two asymmetrical ones. The doorway (which has a heavy Greek Revival frame surrounding the vestibule) is off to one side and the first floor window is a large one set within a heavy Greek frame (similar to the doorway) and having narrow, flanking sidelights. There is a decorative iron 'balcony' in front of this window. Most of the other windows are 6/6 and those on the Smallwood Street side have shutters. The side walls also show star-shaped tie rod ends. The opposite side of the house has a later 1 storey, flat roofed addition. There are two pedimented dormers on the roof; these have 2/2 windows [appear later than the rest of the house, although they are, except for the window mullions, stylistically appropriate].

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Occupying an important corner position, 201 strengthens Washington Street and helps keep it from being visually sucked out towards St. Paul's Lutheran Church. This house is another variant of Cumberland's Greek Revival heritage with its Greek cornice, doorway, windows (note black mullions) etc. 201 compliments 110 and 112 Washington Street, themselves each examples of domestic Greek Revival.

(9B.) Sprigg House

Built in 1846 by William O. Sprigg, banker and civic leader, the old home is now the residence of Mr. & Mrs. William A. Gunter. The house is of unusual architecture and was designed so that its size could be doubled by an addition on the west side. A built-in bookcase, mahogany secretary, and front hall candelabra were part of the original furnishings. During the Civil War the Spriggs, who were Southern sympathizers, were taken into custody and forced to leave the house so that it might be used to house Union officers.


