DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The West Side district unlike other sections of Cumberland has a large number of large, single family, detached residences with front, side, and rear lawns. It contains the Washington Street Historic District which is listed on the National Register of Historic Places; a number of nearby substantial brick homes which were built in the early twentieth century; Greene Street, an early street with a mixed use character and architecture dating from the early nineteenth century through the 1940's Art Deco style Coca Cola Bottling Plant; early twentieth-century housing on Greene Street, Gephart Drive and Braddock Road built in response to the opening of the nearby Kelly Springfield Plant; and the Dingle--an early twentieth century planned community designed by a British landscape architect. The topography in this district is significant: a series of steep hills create a splendid geographic setting for the fine architecture in this district.

STATEMENT OF SIGNIFICANCE

The West Side District contains much of Cumberland's fashionable west side. Traditionally the home of affluent and comfortable industrialists, merchants, and professionals, this area has the finest concentration of residential architectural styles. Washington Street is intimately associated with scores of interesting personalities from Cumberland's past and a number of good quality architects of both national and regional significance. Green Street, a historic settlement area, is another street with a significant number of mid nineteenth-century buildings and early twentieth-century architect designed homes. Western most portion of the district is primarily comprised of twentieth-century development architecture. The colonial, classic, and English domestic revival architecture of west Washington Street is significant and offers continuity to the more historic east end. The Dingle, laid out by an English landscape architect, John Forsythe, is probably the only area in the city in which landscape, siting, and other environmental and design considerations played a major role.

A substantial part of the West Side district has been documented in the National Register nomination form for the Washington Street Historic District. The 1976 architectural and historic survey of the City of Cumberland recommended that this district be contained within the larger eligible area known as the West Side. This form is intended to supplement existing physical descriptions and documented information about Washington Street.¹ (See Appendix)

Many of these buildings appear in plan view on the 1858 map of the city and are among the oldest surviving structures in the district. Although altered, the law offices at 3-5 Washington Street have been in continuous use for over a century. The eastern portion (3 Washington Street) dates from about 1870; the western portion from before 1858. (H-1) The Masonic Temple building or Professional Building, (H-2) as it is now known, is also an early building dating from 1842.² Other documented buildings include the nineteenth century Greek Revival style Academy building (now the Public Library) on Washington Street. (H-3) (See Appendix)

The Allegany County Courthouse is the first known major work of local architect Wright Butler who was extremely active on this street. The 1925 eastern addition was also designed by Wright Butler as was the 1916 western addition.³ (H-4)

The North side of Prospect Square, also documented in the National Register survey, is characteristic of the West Side--a mix of early Greek Revival row houses such as 1 and 17 North Prospect Square and the picturesque Downing-type cottage at 31 North Prospect Square. (H-6) (H-5)

The Romanesque revival house at 103-105 Washington Street probably dates from about the same period as the courthouse. A sophisticated urban building, unlike any known Wright Butler buildings, it could be the work of such an architect as Bruce Price. (H-7) (H-7a) It is a good example of the compatibility of the various styles of architecture on this historic street. Although much later in period than the Federal, Greek Revival, and Italianate buildings nearby, it is compatible with them in scale, set-back, and materials.

The street is already noted for such buildings as the Greek Revival houses at 104 Washington Street and 201 Washington Street (H-8), the Second Empire houses at 401-403 Washington Street (H-9) and 512 Washington Street (H-10), and the eclectic house (with characteristics of both the Italianate and Second Empire styles) at 508 Washington Street (H-11 and H-12). (See Appendix)

Some of the fine nineteenth century houses were altered in the early twentieth century. Wright Butler altered the mid nineteenth century Greek Revival house at 213 Washington Street in 1902. Butler remodeled this three-bay wide, two-story tall brick house into a 3½ story Queen Anne style house with a rounded corner, brick and shingle tower, and his characteristic hip-roofed dormer.⁴ (H-13) Architect Goerge Sansbury is believed to have added the classical stone faced entry to the Second Empire house at 522 Washington Street.⁵ (H-14)

It is the magnificent early twentieth-century Queen Anne and Colonial Revival style residences which have been most neglected in recent surveys.⁶ A characteristic example is the Queen Anne style house at 224 Washington Street which architect Wright Butler designed for Frank Jenvey in 1901.⁷ Butler was a master of the Queen Anne style. He excelled in mixing materials and forms, the hallmarks of this style. This irregularly massed 2½ story brick house has many of the familiar Butler details: the rounded 2½ story bay window which appears to culminate in a shingled tower, the finial topped dormer window, and the oversized first floor windows. The house also has Colonial Revival elements; the columns and balustrade and modillioned porch cornice all appear in Butler's Colonial Revival designs. (H-15) The same mix appears across the street at the Maurice Rosenbaum house at 217 Washington Street. Built around 1900, the house may have been designed by Butler.⁸ The multiplicity of roof angles--the intersecting gables and the conical shaped tower--are characteristic of his work. Influenced by the Colonial Revival, the designer of this house included pairs of Doric columns on the wide veranda and a Palladian window in the shingled gambrel. (H-16)

Almost always eclectic in his residential work, Butler also added Queen Anne and other different stylistic elements to his Colonial Revival houses. The residence he designed at 400 Washington Street in 1901 is an unacademic Georgian Revival house.⁹ The 2½ story, brick house has three dormer windows--one of which appears on a rounded corner and is the characteristically low-slung, squat dormer often used by Butler. In the early twentieth-century, Butler used a rounded corner to soften the lines of the strict Georgian Revival. Ventilators in the form of small swept windows accent the hipped roof. (H-17)

The Devecmon House at 412 Washington Street, built in 1905-1906, was one of Butler's major works.¹⁰ This 4½ story, brick house is the ultimate expression

of the gabled house. The first story is three bays wide and includes a long porch supported by four pairs of Doric columns. The windows are large, three-part windows. The second floor is five bays wide with the central window larger than the four flanking it. These windows have heavy stone lintels and sills. The large $2\frac{1}{2}$ story gable is accented with a modillioned cornice between each floor. The gable is covered with patterned slate shingles. The third floor is four bays wide with each window the same size while the fourth floor has a centered Palladian window. The point of the gable contains an elliptical window in the $\frac{1}{2}$ story. Although containing several Colonial Revival characteristics, the house also has a definite Queen Anne feeling with the intersecting roof lines and side dormers. Devecmon celebrated the completion of the construction with a large party in honor of Wright Butler, the architect, Silas Wise, the builder, and the numerous workmen involved in the project.¹¹ (H-18)

Previous surveys have included the McKaig house at 528 Washington Street. (H-19) This fine and imposing Colonial Revival house is one of the few known works of J. S. Seibert, a civil engineering graduate of Lehigh University, who operated a substantial architectural practice in the Cumberland vicinity in the late nineteenth and early twentieth centuries. This house built in 1905 is one of the latest attributed to him.¹² (See Appendix)

George Sansbury, another prominent local architect and contemporary of Wright Butler, designed a number of the fine homes along Washington Street, particularly in the West end. Among these houses is his own home at 604-606 Washington Street. Built in 1903, this double, Tudor style house is built of brick and shingle.¹³ $2\frac{1}{2}$ story projecting bays culminating in twin, gabled dormers distinguish this very simple house. Diamond pane casement windows accent the dormers. (H-20)

Holmboe and Poe, an architectural firm from Clarksburg, West Virginia, designed the Isaac Blaul house at 309 Washington Street in 1921.¹⁴ This firm may be a successor to Holmboe and Lafferty, a Baltimore firm, which designed the City Hall (See District G) and the Mayor Koons House on Baltimore Avenue (See District D). Both firms worked on these projects with the same builder, W. J. Morley. The Blaul house is a $2\frac{1}{2}$ story, brick house with a green tile, hipped roof with hip-roofed dormers to the east and west. Three bays wide, the house is a simple, straightforward design with a long porch across the first floor. Pairs of wooden columns and a neo-classical balustrade ornament the porch. (H-21)

The $2\frac{1}{2}$ story, brick and shingle house which Wright Butler designed for Thomas Hobbs in 1901 is one of the most eclectic houses in the district.¹⁵ This house at 317 Washington Street, like many Butler houses of this period, has a multiplicity of intersecting and projecting roof lines and dormers. Basically, the house is a $2\frac{1}{2}$ story, intersecting gabled house. The gable facing north has hip-roofed dormers, each with a shed-roofed dormer, projecting from it. The dormer to the east covers a two story porch--each with a balcony--and is supported by two very tall, slender columns on pedestals. The gable running east-west is accented by a two-story bay window which has a tower-like appearance and a one-story bay window to the west. A columned porch runs along the principal or north facade and parts of the east and west facades. The first floor is constructed of brick painted yellow; while the upper floors are covered in green

wooden shingles. The house is a major visual element and one of the most interesting works of local architect Wright Butler. (H-22)

Another interesting house is the Footer home at 310 Washington Street. The movement of the Footers, the owners of a nationally known cleaning and dying establishment, from the once fashionable Decatur Street (See District D) to Washington Street illustrates the position of Washington Street as the home of the elite and affluent in the teens and twenties. This tile roofed cottage has definite associations with both the Bungalow and Colonial Revival styles and is a complicated composition for a builder house. Local contractor Harry Campbell is credited with both designing and building the house.¹⁶ An irregular shaped house, it has a long low slung porch on the south and east sides. The porch is supported by columns on pedestals (one is missing); the entrance is marked by pairs of columns and a pedimented entry at the roofline. The porch is rounded to the east giving the house a fluid appearance. The most distinctive element is the 1½ story, pedimented dormer with balcony which projects above the entry. The house is probably the most original of Campbell's architectural designs. (H-23)

Washington Street had a number of stables and carriage houses at the turn of the century. Some remain--mostly appearing in alleys and along the rear of the property. At least one, however, the building at 617 Washington Street, has been converted into a pleasant residence. (H-24) Such adaptive uses add continuity and vitality to this elegant street as does the old iron railroad bridge. (H-25)

Washington Street has few intrusions. Most are the result of incompatible conversions of one-family houses into multiple family apartments. Such elements as fire escapes intrude into the historic environment. The most glaring intrusion is the destruction of the porch of the Sloan house at 607 Washington Street. This Colonial Revival house designed by architect George Sansbury is truly an eyesore in its present condition.¹⁷ An incomplete paint job has left the house a motley pink and white and the ghost of the porch remains a jarring reminder of this indispensable element. (H-26)

Washington Street, however, is a splendid architectural setting. It is truly representative of the best Cumberland architecture through the centuries. The previously neglected west end of the street, as documented in the digest, is lined with the works of Butler and Sansbury, the two architects most responsible for local design in the early twentieth century. (See Digest and Supplement)

A small part of Greene Street (numbers 1-16) is included in the existing National Register district. The concrete block building at 18 Greene Street, however, is an integral part of the rest of the row. Unused and neglected, this 2½ story building designed in 1904 by Wright Butler is also important as a work by this local architect.¹⁸ The shed-roofed building has several Butler features such as the ½ story oculus windows, the dropped cornice, and second floor oriel. The marquee was probably added in the teens or 1920's. (H-27)

Greene Street, a historic street, also has a number of early buildings--most of which are the transitional Federal/Greek Revival style buildings found in the Decatur Street District (See District D) and Canada/Viaduct District

(See District F). Good examples appear at 69 (H-28) and 130 Greene Street. (H-29) (See Appendix) These buildings appear in plan view on the extant nineteenth century maps of the city. At present the intrusions on Greene Street include the defacing of similar houses with incompatible alterations and sidings. The Greek Revival houses at 71 (H-30) and 122 (H-31) Greene Street have been covered with formstone which hides their original brickwork. The house at 121 Greene Street also has large sized out of scale dormer windows which destroy the original proportions of the house.

It is not just the nineteenth-century houses which make Greene Street a significant place. Greene Street is one of the best streetscapes in the city with its densely built houses of many periods defining the tight street. (H-32) It contains characteristic house forms such as the bracketed, shed-roofed house. Another popular house form appears at 58 Greene Street: the intersecting gabled house with elliptical window in the gable and ornamental lintels.¹⁹ (H-32)

There are also a number of pleasant and substantial Wright Butler designed homes such as the 1903 Colonial Revival/Queen Anne style house at 63 Greene Street (H-35),²⁰ and the 2½ story, 1901 Queen Anne style house at 210 Greene Street (H-36).²¹

It is also traditionally a mixed-use street. The old office building of the Holly Water Works at 72 Greene Street is now used as a senior citizens community center. (H-37) This classically influenced building is an integral part of the streetscape as is the third of the city's mission style 1920's fire stations-- Engine Company #3. (H-38) The last of the three to be constructed, this tile-roofed fire house was built in 1927 and is also an important element in the fine collection of picturesque firehouses in Cumberland. Unfortunately, automotive related intrusions such as service stations have begun to locate on Greene Street. The Gulf Station adjacent to the 1940 Art Deco style Coca Cola Bottling Company has destroyed the once tightly defined streetscape. (H-39)

Fayette Street is another historic street in the West Side district. The nineteenth-century German Catholic Church--St. Peter's and Paul's--and the adjacent monastery are not only architecturally and historically significant, they are also important visual elements. Sited high on one of West Side's hills, they are visible from much of the city. (H-40, 41, and 42)

The street also has a number of fine nineteenth-century residences such as the three-story, brick, hip-roofed house at 201 Fayette Street. A late Greek Revival style house, it is three-bays wide and three-bays deep. A belt course runs near the top of the attic windows. Internal chimneys appear on the east side. (H-43) One of the most picturesque houses in Cumberland is opposite at 218 Fayette Street. This 1½ story, three-bay cottage was influenced by the popular A. J. Downing pattern books. This mid nineteenth-century house has intersecting pitched roofs--resulting in a steep pitched, ornamental gable facing Fayette Street. The house is excellently maintained and the brick sidewalk in front enhances the historic character of the house. (H-44 and 45) Less grand but also significant on Fayette Street is the Italianate, frame house at 208 Fayette Street. (H-46)

Near the iron railroad bridge on Fayette Street stands a fine, 2½ story, Second Empire style house. Little altered, this six-bay wide, two-bay deep house with its slate mansard roof and gabled dormers is the match of many of the elegant homes one street away on Washington Street. (H-47)

Other West Side streets such as Cumberland Street are representative of the early twentieth century architecture preferred by Cumberland's middle class population. A typical streetscape occurs in the block between 400 and 500 Cumberland Street where the houses are a mix of architect designed houses by Wright Butler, builder houses by Silas Wise, and Sears and Roebuck pattern houses selected by the owners. Built of brick with slate and wooden shingles featured prominently, these houses with their uniform setbacks, similar materials, and varying rooflines create a fine streetscape defined by the stone retaining walls. (H-48)

Other builder houses also appear on Cumberland Street. A typical example is the 2½ story, brick and shingle house at 302 Cumberland Street. Built as speculative housing in 1906 by W. T. Taylor, this type of house--with its shingled gables, columned porch, and two-story bay window--appears in all sections of the city.²² (H-49) Earlier houses such as the builder's Queen Anne style house at 231-233-235 Cumberland Street also occur in the West Side. (H-50) It is the steep topography of the area and environmental features such as the stepped alleys that make a street like Cumberland Street even more distinctive. (H-51)

A number of fine Georgian Revival and Mission Style houses appear on Mountain View Drive, Magruder, and Schley Streets. The most distinctive is the imposing Sperry house designed by local architect Wright Butler in 1914. Built of hollow tile covered with cement stucco, this house was built for W. L. Sperry, president of the Cumberland Hydraulic Cement Company.²³ This 2½ story house, with its low hipped, tile roof and sited on the point of Mountain View Drive, looks out over the North End and commands a splendid view as the name of the street implies. (H-63) This house is the finest of many cement covered, hollow-tile construction houses built in Cumberland between 1911 and 1925. Grander than the delightful bungalows such as the one at 342 Saratoga Street (H-52), the house has more in common with the academic Georgian Revival Louis Stein house at 223 Schley Street also designed by Wright Butler. (H-53)

Such houses as the Sperry and Stein residences are similar in feeling to the contemporary residential development in the Dingle. Laid out by British landscape architect John Forsythe, the area was designed as a planned community. Interrupted by two world wars and the depression, the development of the Dingle was not completed until after World War II. The layout, however, and compatibility of the twentieth century architecture make the West Side district distinctive. The juxtaposition of fanciful bungalows, Colonial Revival style houses, and English Todor houses makes the Dingle representative of twentieth-century architecture. (H-54, H-55, and H-56)

The West Side district, like much of the rest of the city, has areas of working-class architecture. Well-maintained builder's houses line the hillsides of Avirett Street. (H-57) 2½ story, gabled houses, all with a porch, and with a variety of details such as sunflowers, slate gables, and lintels are characteristic

of the development of the first years of the twentieth century. The 1920's, however, saw the last big building boom in the district.

The establishment of the Kelly Springfield Tire Plant just outside this district made undeveloped land attractive to builders in the late teens and 1920's. The most notable building occurred on Greene Street, Gephart Drive, and Braddock Road where the Nicola Building Company built rows of houses for the Cumberland Homes Company. These low-cost, two-story houses, most of them cement covered hollow tile or metal lathe, were popular housing for Kelly Springfield workers. Although most have been altered, these houses copied from the pages of Pittsburgh architect, George Schwan's pattern book, are still a varied and harmonious grouping of early twentieth-century worker housing.²⁴ (H-58, 59, 60, and 61)

The West Side district, a large and diverse area, with architecture built for all classes in all periods is more representative of the total history of the City of Cumberland than any other district in the city. It covers the city from the early days of Fort Cumberland to the industrial development of Kelly Springfield. It has a splendid geographic setting of wide topographic variations, many superb streetscapes, and scores of significant buildings by local architects, Wright Butler, George Sansbury, and J. S. Seibert, and numerous local builders of importance.



This information was useful in determining ages of buildings and in identifying the architects and builders who were active within the district in certain periods. A notation of M1858 is the earliest documentation contained in the digest. Although a number of the buildings existed prior to 1858--some as early as 1790. Pre-1858 is a convenient early date to use for the remaining log, Federal, and Greek Revival style buildings built in Cumberland before the Civil War. These buildings as a group are the major surviving physical record of Cumberland's early history. A notation of M1875 indicates that a building was constructed between 1858 and 1875.

The West Side neighborhood, a large and diverse area, consists largely of residential buildings constructed for all classes from the mid 19th century through the early 20th century and is more representative of the total history of the City of Cumberland than any other district in the city. It covers the city from the early days of Fort Cumberland to the industrial development of Kelly Springfield. The district experienced great growth in the late teens and 1920's as a result of the establishment of the Kelly Springfield Plant just outside the district. The district has a splendid geographic setting of wide topographic variations, many superb streetscapes, and scores of significant buildings by local architects. The house at 677 Fayette Street is typical of those built in the district in the 1910s and 1920s for working class residents.




