The Borden Mines Schoolhouse is located on the eastern side of Route 36 at Borden Mines. The building is one story tall and measures eight bays wide and five bays deep. The frame walls are covered with plastic siding.

The Borden Mining Company built the schoolhouse between 1850 and 1879. The company constructed a village near its mine north of Frostburg in the late 1840's. In 1879 the company conveyed this building and another schoolhouse in Borden Shaft to the county school board.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This rectangular schoolhouse, now a dwelling, is one story tall and eight bays wide on the southeastern-facing facade. Wall construction is frame covered with plastic siding. The building rests on a high foundation of precast cement block in an artificial stone pattern. The gable hipped roof is covered with asphalt shingles. Eaves consist of an aluminum cornice, soffit and frieze.

Three porches, two on the facade and one on the northwestern elevation, have hipped roofs supported by capped square columns on the facade and by square posts on the northwestern elevation. Two entrances on the facade include one light transoms and modern doors. Two entrances are located in the center of the northwestern elevation. Windows are tall 6/6 wooden sashes. Two brick chimneys with tall stacks and decoratively corbeled caps are located inside end. A smaller brick chimney located on the interior of the building has a corbeled cap.

STATEMENT OF SIGNIFICANCE

The public school system of Allegany County was established in 1865 but it was not until the 1870's that adequate public schoolhouses were erected. Until that time some of the coal companies operating in the George's Creek mining region provided schools for their miners' children. Many of the schoolhouses in the region were built by coal companies and later deeded to the Board of School commissioners. Many contemporary observers noted the intelligence and the high rate of literacy of the mining population even before the establishment of the school system. (Harvey pp 107-111 and "school properties")

The Borden Mines Schoolhouse was built between 1850 and 1879 by the Borden Mining company. The company built a village around its mine north of Frostburg in the late 1840's. (Scarf p. 1477) In 1879 the company conveyed this building and the school in Borden Shaft to the school board. The deed mentions "the school house erected" on the Borden Mines school lot. (Land Records) During the mid-twentieth century the county abandoned the school and the property reverted to the Borden Mining Company which sold it as a dwelling.

Notes: By this deed the Borden Mining Company conveyed schoolhouse lots in Borden Mines and Borden Shaft to the Public School System. The Deed mentions "The schoolhouse erected on said lot" in Borden Mines. The Deed also carried a provision that if the school board should cease to use the property as a public school, the lot was to revert to the Borden Mining Company. This provision was apparently carried out.
