The Keller Board & Batten House is a two story, two family dwelling that is typical of the type of construction utilized by the George's Creek Coal and Iron Company during the first half of the 19th century. These houses usually had three or four rooms and a shed kitchen for each family.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Keller Board and Batten House is located at 3 Water Station Run Road, Lonaconing, Allegany County.

The Keller House is a two story, four bay wide, rectangular, frame structure that has been covered with board and batten. The roof is gabled with a boxed cornice and returns and has been covered with replaced asphalt shingles. A small one story addition with a gable roof abuts the main block on the southeast side and the entire structure rests on a low stone foundation. Windows in the Keller House are double hung pegged, wooden sash frames with six over six lights and plain trim. The house has two main entrances which are located on the southwest facade. Both have verticle paneled doors with original hardware and transom lights. Originally a four bay front end porch covered the two entrances, but it has since been removed. Two original brick chimneys are located in the interior of the house.

STATEMENT OF SIGNIFICANCE

The Keller Board and Batten House is typical of a "block" or a two family dwelling constructed by the George's Creek Iron and Coal Company toward the middle of the 19th century. These houses were usually two stories high, of frame construction, providing three or four rooms and sometimes a shed kitchen for each occupant.¹ Double houses constructed in 1856 cost approximately \$400.00.²


