DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly, semi-wooded area on Rt. 55 at the south end of the town of Miller. The house faces northwest. It is a two story, three bay by one bay gable roof structure with a gable end facade. A wooden porch, supported by chamford posts with scrolled brackets and jig-sawn balustrades, covers the facade bays. The central facade entrance has a transom.

Two over two sash windows, with drip molding, light the house. The house rests on a stone foundation. Asbestos shingles cover the house with asphalt shingles on the roof.


