

Tibbets Stick Sytle House
AL-VI-D-209
112 Main St. Ext. Westernport
1890's

This residence was built during the 1890's by "Bud" Tibbets. In 1913 it was purchased by George T. Sliger who removed a small original porch replacing it with the elaborate porch with fluted and scrolled Ionic columns.

The house was built with the asymmetric Facades, intersecting gables, and multiple light windows common to the stick style. The stick work on the gable ends and the exposed framing, "intersecting at right angles applied over the clapboard surface" are also characteristic of this "almost purely American nineteenth century residential style."

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The building consists of a two and one-half story, four bays wide frame structure. The larger part of the building is a gable flank rectangular block. A gable front wing is perpendicular to the main block. The gable end of the wing comprises most of the principle facade. Wall construction is of board and moulded batten on the first floor and clapboard elsewhere excepting the gable end of the wing which has flush board and a band of stick designed in a grid along the base of the second and one-half floor and between two second floor windows.

The building rests on a high stone foundation of random rubble with a beveled wooden water table. The gable flank roof is covered with asphalt shingles. Eaves on the main blocks' gable ends consist of a close pent cornice and frieze. Eaves of the wing consist of a cornice, soffit, bed mould and frieze with simple brackets on the flanks. Wall features include flanged siding between the stories and a sunrise stick design on the peaks of the gable ends and the porch roof. A five sided bay is on the northern corner of the first floor. Two original corbeled brick chimneys are located inside end.

The main entrance, offset on the northwestern facade, includes a boarded up transom and a replaced six panel door. Windows are pegged one over one lights. There are three, three light casement windows in the peak of each gable end. Two windows unobservable on the southwest are twenty-five light simple stained glass windows. The porch is covered with a hipped roof with a central gable with the stick design. Below the roof is a wooden lintel with a pediment and dentils that alternate in size. Supporting the lintel are five tapered and fluted Ionic columns with scrolled wooden caps with elaborate moulding. The rail of the porch is covered with imbricated wooden shingles. A small board and moulded batten addition on the southeast has a pyramidal roof.


