DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The (Mazie Smith) Stoll House is a two-and-a-half story, five-bay stucco over brick dwelling flanked by two story wings. It faces east on Crain Highway, near the intersection of Furnace Branch Rd. The main block was built in the mid-19th century, but it was stuccoed, enlarged and extensively renovated c. 1926.

A four bay porch with a flat roof supported by pillars extends across the center of the west elevation.

Windows containing 6/6 light double hung sash are spaced evenly on the front and rear elevations of the main block. On the wings, the front and rear windows on the second story are casements. The north wing has a row of three windows containing 6/6 light sash, while the first story, south displays a square one story bay addition.

The entrance is in the center bay, front elevation. It is surrounded by a triangular pediment with pilasters.

The gable roof on the main block is parallel to those on the wings. Dormers are on both sides: two gabled dormers on the west slope and a shed dormer between gabled dormers on the east. The gable ends of the center block and flanking wings are stepped. The end chimneys (also stuccoed) are not identical. The exterior chimney on the south wall extends into the wing, while the north chimney rises from within the wall. The wooden cornice is molded

A large garden at the rear of the house contains a graveyard; the tombstones, dating from the mid 1800's, are those of the Smith family, who had a truck farm for many years. With a Mc Donalds directly across the street and garden apts on what was once farm land around it, this house has come on hard times. However, the present occupant says that the house was only a brick shell in 1926 before it was renovated.

It was not possible to see the interior, but the occupant says it has four open fireplaces.

STATEMENT OF SIGNIFICANCE

According to the present occupant, the house was a brick shell in 1926 when the owner (now 91) and her husband, a cabinet maker, moved into it. It was probably built in the mid 19th century by a member of the Smith family, who owned large farms in what is now a heavily developed commercial part of Glen Burnie. In the late 19th century strawberries became the principal crop, the pickers coming from Baltimore at harvest time. (See AA-119 for information on strawberry picking in Anne Arundel Co. A 104 acre farm, belonging to G.W. Smith is shown at approximately this location on the 1878 Hopkins Map of Anne Arundel County.
