DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Two highways have been built across the boundaries of "Locust Farm" in the last 30 years, leaving only a third of its original acreage intact. Beef and dairy cattle have been raised there for several generations. The house and barns have a prominent location on a hill-top just south of Rte. 50.

The house at "Locust Farm" was built in 1848 by the great-grandfather of the present owner. The builder, whose name was also Benjamin Watkins, was a physician who gave up his practice and turned his full attention to farming after accidentally mis-diagnosing a patient.

The house was situated near a much older dwelling which was considered too small and run-down to be habitable. All that remains of this structure is its stairway, incorporated into the new house as the basement steps. The treads and bannister are very worn but still intact. The spindles are gone but the holes where they were set into the treads are still visible.

The present house is frame, 2 stories, 5 bays, standing on a full, brick lined basement. The plan has a center hall with two large rooms on each side. There are two interior chimneys on each end, serving four fireplaces on each level, including the basement. The owner remembers that the cooking was done in the basement in winter and the food sent upstairs on a dumb-waiter. In spring, seven or eight men were required to carry the huge iron cook-stove outside to the summer-kitchen. The process was reversed in the fall. The summer-kitchen, no longer standing, was a rough, wooden building with unscreened windows. The meat house, still in use, is located in the yard behind the house. It has board-and-batten siding with a hand-wrought iron latch and strap hinges on the door.

The exterior of the house has been covered with asbestos shingle and the design of the porches changed. The interior details are simple and virtually unchanged. Much of the original furniture is still there.

The house is in good condition. It is an unusual variation of the traditional side-hall, double-parlor plan, making it quite large and impressive.
