DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Broadview Apartments is a two-story frame building situated on a rise of land overlooking the small railroad community of Harmans on the southeast corner of the intersection of Md. Routes 176 and 170.

The rectangular building, which rests on brick foundation and is covered with asbestos shingles, is dominated by its gambrel roof with jerkinheads. There is a central gable, also with a gambrel roof and jerkinhead projecting from the northern slope of the roof. All three gable ends are sheathed with imbricated wooden shingles. There are two gable roofed dormers flanking the central gable on the north side and two identical dormers on the south side.

There is a single internal brick chimney toward the eastern end of the building.

The front (north) facade of the building is composed of five bays, with a central entrance on the first story. This front door is enclosed by two sides and one transom lights and is sheltered by a one-story gable roofed pontice.

On the second story level, the inner bay on the eastern side lacks a window, thus disrupting the symmetry of the fenestration.

The rear (south) facade receives basically the same treatment as the front facade. The plain box cornice runs the length of the front and rear facades, and continues partially on the east and west ends.

The grounds are treated simply. The front lawn, graced by several oak trees, drops rather steeply to Route 176.

There is a small board and batten garage to the southeast of the house.

It was not possible for the surveyors to view the interior.

STATEMENT OF SIGNIFICANCE

This would appear to be the J. Hawkins house located in G. M. Hopkins 1878 Atlas of Anne Arundel County. No deed or other research has been performed.

Larry R. Paul and Anne H.S. Ogee of the Maryland Historical Trust Anne Arundel County Committee have identified the house as such, although they referred to it as ~~the~~ Richard Hawkins. The house was originally the center of a 132-acre farm. Most of the land was sold to the Baltimore Washington Airport in 1947.

I thank you for the information
you sent me.

I have enclosed two pictures
of the house before it was
made into apartments.

There was a large kitchen on
the south east corner off the
dining room, a pantry, porch
off the kitchen and dining room.
An apartment was made on
the north west side of the house
and another kitchen added.

This was his family member.
Five generations of Clarks
have lived in the house.

The man sitting on the porch
in one of the pictures is my
grandfather, Samuel V
Clark. I lived in the house
from about 1920-1934. The
house is now owned by my
cousins Marbury and Shirley
Clark.

There were eight large rooms
in the main house, one small
room upstairs in the center
of the front of the house. a large
hall upstairs and also on the

first floor. A summer
kitchen was off the dining room
porch.

The outbuildings were two
Chicken houses, a building for
storage, a meat house and
a double fuel shed, one side
for coal and the other for wood.

The large barn and other buildings
were on the other side of the
road.

There was another house
at the bottom of the hill,
I think the Hawkins lived

there before the house on the
hill was built. a pump
house was at the well at the
bottom of the hill. a
shanty was down the road
beyond that.

There were a lot more large
trees but have been blown
down by wind storms.

Hot beds and a shed were
down the hill in back of
the house.
