DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Built in about 1880, this is a simple, 2 story house on a side-hall, double-parlor plan with interior chimneys and a square hipped roof. The kitchen is a 3-bay wing with an A roof and a large exterior chimney. It is attached to the east side of the house.

The interior details are simple: door and window frames have mitered corners. The mantels are plain. Central heating has been installed but little else has changed. The floors are made of random width Georgia Pine. They extend the full length of the 30 foot hall in one piece.

The house was occupied from 1889 to 1910 by Marshall Howard of Baltimore. In 1910 it was bought by the Jones family. Two of the children still live in the house.

STATEMENT OF SIGNIFICANCE

The Jones residence is the end example of a long evolution of one type of house. The side-hall, double-parlor plan was common in the 19th century. The majority of houses of this type were built between 1820 and 1860. They have A-roofs or gambrel roofs. This house with its square hipped roof and Victorian interior detailing illustrates the transition of styles in the late 19th century.
