This large, well-kept, tobacco barn was probably built in the 1840's when the "Greenock Park Farm" was established.

The shed-roofed addition to the south side of the main barn has a brick basement which was probably intended to be used as a room for stripping the tobacco.

All of the framing appears original and in good condition. The present roof is tin.
