DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This Georgian mansion is situated on one of the highest points in Annapolis, and originally had extensive grounds stretching from Duke of Gloucester Street on the northeast to Spa Creek on the southwest. The extent of the grounds has been greatly reduced over the years, but the immediate yard around the house is intact.

The house itself is a rectangular, two story brick structure above a high basement. Its overall dimensions are 54 feet 2 inches by 44 feet 10 inches. Both entrance and garden fronts have five bays, although the garden facade has a central three bay pedimented pavillion. The end walls have only two bays each. Crowning the house is a shallow deck-on-hip roof pierced by two massive interior chimneys with corbeled caps. Surrounding the base of the roof is a wooden entablature with a frieze of enriched consoles between which are paneled metopes.

The front walls as well as the chimneys are laid in header bond, while the ends are in Flemish bond. There is a rubbed brick belt course, and the windows are all topped with rubbed and gauged flat arches.

The door on the garden front is sheltered by a small Doric pedimented porch supported on two columns. The street door is framed by a pedimented frontispiece corresponding closely in form and detail to the porch. Both these entrances retain their original stone steps. All the windows are surrounded by architrave moldings.

The interior scheme of the Scott House is carefully proportioned. The stair hall, centrally located on the southwest side of the house, contains an L-shaped stair. It has an open string with console brackets ornamented with low-relief carving and a fret band below the brackets. The molded handrail with its deep undercut for the fingers is supported on square balusters. Separating the entrance hall from the stair hall is an archway framed on the stair hall side by fluted Ionic pilasters on pedestals which support a full entablature with plain pulvinated frieze. The modillion cornice of the entablature joins into the cornice surrounding the room. The walls of the entrance hall, stair hall, north and east rooms are ornamented with plaster panels both above and below the chair rail. The chimney pieces in all the principal rooms are richly ornamented with architectural detail. Fortunately, nearly all the significant trim throughout the house, including doors, chair rails, cornices, baseboards and floors is intact and in a generally good state of preservation. Some of the ceiling have been covered by stamped sheet metal and the floors with modern composition tiles, but these have caused no permanent damage.

STATEMENT OF SIGNIFICANCE

Few American houses combine such superlative architectural quality and significant historical associations as does the Upton Scott House. A building of almost European richness and sophistication, the Scott House is a masterpiece of colonial craftsmanship and design. Its builder and first owner, Dr. Upton Scott, was a native of Ireland and came to this country in 1759 as the personal physician of Governor Horatio Sharpe. Not long after his arrival, he married Elizabeth Ross, a daughter of John Ross, Lord Baltimore's Secretary of the Council and holder of other colonial offices. As time went on Scott inherited these sinecures from his father-in-law, and with his flourishing medical practice the Belfast doctor was able to plan one of the finest houses in Annapolis. So ambitious was his project that Daniel Dulany wrote in 1764 to Councilor Robert Carter in Williamsburg that "Dr. Scott has built the best Town House in America."

Begun in 1762 and completed by 1765, the house was surrounded with handsome gardens and had a greenhouse for rare plants. Although no documents have yet come to light to confirm it, the parallels between the architectural details of the Scott House, Whitehall, the Chase House, and the Hammond-Harwood House, and other Annapolis mansions make it evident that common craftsmen and designers worked on all of these buildings. One of these may have been William Buckland, architect for many of Tidewater Maryland's finest homes, even though the Scott House was completed before Buckland moved to Annapolis.

During the Revolution, Dr. Scott and his wife moved to Ireland, but they returned to their house in Annapolis, in 1780, to live there for the rest of their lives. Francis Scott Key, author of the National Anthem, was a great-nephew of Mrs. Scott, and during the seven years that he was a student at St. John's College and Preparatory School he lived at the Scott House.

Maryland's last colonial governor, Robert Eden, died at the house while visiting Dr. Scott in 1784. He had returned from England in an unsuccessful attempt to reclaim his confiscated property.

7. DESCRIPTION, continued

Upton Scott House has been rated "Outstanding" on the Historic Annapolis, Inc. Architectural Survey begun in 1970. A panel of nationally known experts in the field of architectural history has taken an inventory on each of 3,000 buildings in the Annapolis National Historic District. Important sites are grouped into four categories (outstanding, excellent, notable and worthy of mention). Upton Scott House is one of less than 75 placed in the highest category. Plans are being developed by the current owner for complete renovation of the property and restoration of the house to a single-family dwelling. An archaeological study of the property is underway.

8. SIGNIFICANCE, continued

Following Mr. Scott's death in 1819, the house was held for a short time by heirs. It was soon bought by Dennis Claude, one of Annapolis' most successful 19th century entrepreneurs, whose heirs sold it in 1883 to the Sisters of Mercy. It was later inhabited by the Sisters of Notre Dame who occupied it until its recent sale by the Archdiocese to Mrs. Coleman duPont.

Upton Scott House has some of the best Georgian detailing in the city; massive interior chimneys, slightly projecting entrance pavillion with pedimented gable, heavy molded cornice with modillions, half round window framed with stone voussoirs, splayed brick arches at first and second floor windows, brick string courses, molded watertable, entrance porch with pediment and classic frieze of metapes and triglyphs, mutules in rakes; Classic porch at rear of garden wall, exceptional interior.


