DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The nucleus of this rambling complex is made up of 2 gable roofed, 2 story structures which are connected by a 2 story, flat roofed 2 bay section. The flanks of these gable roofed sections, with which the gable roofs run parallel, are oriented in a N.E. by S.W. direction: the one on the north is quite short with only 2 windows, whereas the one on the south is deeper, with 3 windows on the flank, and has fish scale shingling on the second story and the main entrance in the central bay. There are additions on the southwest and northeast sides, and much of the complex is enveloped by a 1 story porch, carried on columns, which is screened in some sections, fully enclosed in others, and open near the main entrance.

According to a school project, Discovering our School Community, by Oma Ruth Foster and Jean Clark, 1951, Locust Lodge sits on the site of one of the 2 big farms, the Thomas Farm, also called Greenock Farm, which constituted the entire western half of Riviera Beach in the early 19th century. Allegedly the Thomas Farmhouse is Locust Lodge, possibly the oldest house in the area. Graves near the Lodge for the Thomas family date from 1821 to 1887.

On the 1878 G. M. Hopkins map, as well as the 1860 Martenet map, Joseph T. Thomas is shown as owner. The Lodge is shown as the same location on the 1907, 1917, 1924, 1931, and 1949 geological Survey Maps.


