The Ralph Bunche School, now Ralph Bunche Community Center in Mill Swamp/Edgewater in Anne Arundel County is eligible for the Register under Criteria A for education. The Ralph Bunche School was built circa 1930 as a school for black children. It is one of fifteen Rosenwald Schools built in the County between 1920 and 1932. Rosenwald Schools were named for Julius Rosenwald, a wealthy philanthropist who funded the construction of over 5,000 black schools throughout the south. This effort has been described as the most influential philanthropic force for blacks in the early 20th century. Funding was awarded on a matching basis. Three area black churches donated the land on which the Ralph Bunche School was constructed.

The Rosenwald Foundation developed plans for model schools which were used by funding recipients. Although the Ralph Bunche School has been altered over time and in 1951 had a large addition added to it, it retains its original plan and massing and is still identifiable as a Rosenwald school.





The following information comes from Benjamin Collins (b.1895), 501 Fiddler's Hill Rd, Edgewater, Md.

In the 1920's, three black churches in the area (Chew's Memorial United Methodist in Owensville; Hope Memor. Methodist in S. River, now Edgewater; St. Mark's in Mayo) joined together and bought several acres from Richard Neal *, at \$15 per acre, on the north side of Mill Swamp Rd., at juncture with Muddy Creek Rd.

The Churches gave 4 1/2 acres of the parcel to Re County to build an elementary school for black children. The County built the Ralph Bunche School c. 1930, according to Mrs. Pearl Downs (b.1920) (phone 798-1156, Edgewater) who was a member of the first class to attend the two-room school.

The school was closed after court-ordered integration in 1956. Now is called The Ralph J. Bunche Community Center, Inc.; houses a day care center.
