DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The original fabric of the Masemore Mill is limited to its stone walls and the steel overshot wheel at the south end. The structure is rectangular in plan, built into a bank (to accomodate the mill race to the wheel) yielding one storey on the west elevation and two on the east. There is a gable roof with north-south ridge, the gable ends filled in with clapboard frame. Two gabled dormers sit on each slope of the roof. There is a massive stone chimney at the northeast corner, built into the walls and rising several feet above them. Fenestration is paired casements, with either three or eight lights per leaf. Windows are irregularly placed throughout except on the west, which is symmetrically composed with two windows and the primary entrance (into the upper storey). On the south, above the mill wheel (which is larger than the lower storey) is a large bow-window of vertical casements.

Among the most interesting features of the mill is a carved stone set into the north wall with the inscription "CW & NF, May 2 1797". The mill pond still exists across Masemore Road to the west, as does most of the run-off ditch. There are several fieldstone outbuildings, all of recent construction, individually of little interest except that they are part of this small complex of stone buildings.

STATEMENT OF SIGNIFICANCE

A stone placque in the wall is marked "CW" and "NF" for Christopher Walker and Nicholas Foster who built the mill in 1797. Foster was the son of John Foster, patentee of Fosters Ramble. Melchoir Armacost bought some of the tract in 1834; these tracts were called Stony Acres and Partnership. (Information from Mr. duBel, May 1968).

The mill is shown on the 1850 map by J.C. Sidney as Nicholas Stiltz Mill and on 1877 atlas as David Donaldson's. Also called Masemore Mill, it is a fieldstone structure now converted into a home; located on Masemore Road and Bush Cabin Branch west of Bunkerhill Road. The mill wheel, millrace, and dam are intact. Now part of Gunpowder State Park, an excellent view from downstream of the mill.

Very little can be done to further damage the integrity of this mill, which is now, for all intents and purposes, a "site". Routine maintenance (especially of the water wheel, which is apt to be forgotten), should be carried out, and care should be taken to ensure occupation by responsible tenants, like the current ones. Interpretation beyond a placque would be unrealistic but the scenic nature of the mill and related structures (see Erdman house) demand that drastic changes be resisted.


