Once a grainery, this house, along with the spring house and barn, were outbuildings supporting a farm now known as the Cumberland House and once known as Bosley's Inheritance. Remodelled in modern times, the grainery is typical of its type in the region with its buttressed stone walls supporting a frame superstructure. The barn may be the oldest in the area if it is the same structure mentioned on the place in the 1798 Federal Direct Tax.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Macfarlane House is the adapted grainery of the farm now known as the Cumberland House (q.v.). Its south wall is of stone, nearly two storeys in height; a massive buttress extends south from its southeast corner. Two small vents in the second storey are closed with header bricks spaced apart. The east end is of frame construction and a short two-bay, two-storey frame addition extends from the west end; a shed-roofed stuccoed-concrete block addition is against the north side. Internally, the log joists of the second floor structure are retained and exposed.

East of the grainery/house is a stone spring house, partly below grade, its entrance is its west end with small ventilating openings in other walls.

Southeast of the grainery/house is a stone barn, its long sides facing east and west, without the customary sheltered south wall. Tall wide openings are centered on the east and west sides; a secondary entrance is through the stone wall north of the west entrance. Narrow ventilating slots are in all areas of stone walls. Internally, the original roof and loft framing has been removed. The barn measures approximately 20 by 50 feet.

A stone addition at the north end of the barn is in ruins; most of its north wall stands out the entire roof structure and portions of the east and west walls have disappeared. Stone walls surround the former barnyard to the east.

STATEMENT OF SIGNIFICANCE

The MacFarlane House is closely related to the Cumberland House (q.v.). It is adapted from the grainery of "Bosley's Inheritance" which belonged to Caleb Bosley. Remodelled in modern times, this was a typical grainery with buttressed stone walls supporting a frame superstructure. The style is distinctive in this part of Baltimore County.

The 1798 Federal tax assessment lists Caleb Bosley as owning a log house with a log kitchen and "barn and stables, etc." at Bosley's Inheritance. Although there is no actual proof, architectural analysis indicates that this barn may have survived from that period, in which case it is the oldest barn in this area.
