The dwelling on Delight Farm is located near the historic village of Butler in the Eighth District in Baltimore County. It is the third largest district of the county covering over 62 square miles. In 1881, it had a population of approximately 6000, which was down over a thousand from a decade prior. During this period, its primary source of income was its mining for iron ore, marble, and limestone. It also maintained numerous mills grist and saw mills in addition to paper factories. According to Scharf in 1881, the village of Butler consisted of a population of 200 maintaining a public school, the Black Rock Methodist Episcopal Church, and a Baptist Church. The Huff House appears on the 1850 Atlas as Z. Coles, and then on the 1877 Hopkins Atlas it belongs to Thomas Pearce. The 1915 Bromley Atlas continues to depict Thomas Pearce at this farm with 225 acres.

Constructed circa 1830, this Federal-style dwelling sits on a sloping grassy lot in a rural landscape with small foundation plantings and a gravel driveway. It is two-and-a-half stories high and five bays wide with a central passage plan. It is clad with stucco and sits on a solid parged foundation. A one-story full-width porch with a half-hipped roof covers the façade and is supported with Tuscan wood posts and a brick pier foundation. The central entrance contains a double-leaf wood paneled door and is illuminated with 3-light and dado panel sidelights and a 10-light transom. The center window bay on the second story contains a tripartite window of a 6/6 double-hung sash flanked by a 2/2 double-hung sash. The remaining windows are 6/6 double-hung wood sash. Rising above the cross-gable roof are three imposing rebuilt interior-end brick chimneys. Features of the house include a paneled door reveal, a molded wood cornice with a slight overhang, a wood denticulated hood crowns for the windows. This dwelling has a two-story T-shaped addition on the rear elevation. Several historic outbuildings are associated with this property, including a garage, shed, and a drive-thru barn.

Constructed circa 1830, this Federal-style dwelling sits on a sloping grassy lot in a rural landscape with small foundation plantings and a gravel driveway. It is two-and-a-half stories high and five bays wide with a central passage plan. It is clad with stucco and sits on a solid parged foundation. A one-story full-width porch with a half-hipped roof covers the façade and is supported with Tuscan wood posts and a brick pier foundation. The central entrance contains a double-leaf wood paneled door and is illuminated with 3-light and dado panel sidelights and a 10-light transom. The center window bay on the second story contains a tripartite window of a 6/6 double-hung sash flanked by a 2/2 double-hung sash. The remaining windows are 6/6 double-hung wood sash. Rising above the cross-gable roof are three imposing rebuilt interior-end brick chimneys. Features of the house include a paneled door reveal, a molded wood cornice with a slight overhang, a wood denticulated hood crowns for the windows. This dwelling has a two-story T-shaped addition on the rear elevation.

Several historic outbuildings are associated with this property, including a garage, shed, and a drive-thru barn. The circa 1950 garage is 1-story high and four bays wide constructed of concrete blocks. Each bay contains a roll-up vinyl panel door, and the building is capped with a side-gable standing-seam metal roof. The circa 1950 wood-frame shed is one-story high and one bay wide. It contains a single-leaf vertical board door and is clad with vertical board siding. The front-gable roof is covered with standing-seam metal and features overhanging eaves. The circa 1950 wood frame drive-thru barn is one-story high and five bays wide. It sits on a poured concrete foundation and is clad with vertical board siding. It has three open bays and two single-leaf vertical board doors. The front-gable roof is sheathed with standing-seam metal. Non-historic outbuildings and structures include an in-ground concrete pool, and a circa 1990s pool house.



**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

Delight Farm is a two storey house, five bays in length, of stone, finished with stucco; its principal facade is to the west. A frame wing, four bays in length, three storeys high, extends from its north end, walls and roof coinciding with the original. A datestone high in the south gable of the original part of the house is carved

1854

The north wing replaced an earlier lower kitchen wing ca. 1912.

Flush chimneys of brick rise above each gable of the original house and a small single-flue brick chimney rises internally at the north end of the north wing.

The easterly roof slope extends beyond the east wall of the house to cover a two storey gallery. A small one-room wing with stuccoed stone walls extends east of the northerly two bays of the original house, its roof an even longer extension of the easterly slope above; this wing appears to be original to the house and a small brick chimney rises from its southeast corner. Early in the 20th century, this small rear wing was extended, in frame construction, to the south, east of the original house's central bay.

The gallery form was extended across the east side of the north wing, terminating at an enclosed bay at the north end.

Typical windows in the original house are 6/6, formerly with louvred blinds; an applied dentiled cornice is above each. The central window in the second storey, west front, is a tripartite window: a 6/6 flanked by a single 2/2 on each side, the latter sash being one-third the width of the former.

It restates the triple motif of the principal entrance below with double doors, sidelights and transom. A one-storey shed-roofed porch extends across the entire west front of the original house.

Windows in the north wing are 6/6 in the first two storeys, 6/3 in the third.

Internally, a central hall is flanked by a single room on each side. The principal stair rises at the east end of the central hall with intermediate landings, to the third floor; its oval cherry rail is supported by massive turned maple newels and round tapered chestnut balusters. Generally all interior openings are trimmed with plain beaded architrave with raked head with an echinus cornice. Doors generally are of four raised panels with loose ogee mouldings. Mantels consist of plain pilasters supporting a plain frieze, bedmoulding and plain shelf. Interior trim of the small east room is identical to that elsewhere in the house; it has a small fireplace in its southeast corner.

The second floor plan is similar to the first, with a hall subtracted from the east side of the northerly room to serve the early 20th century north wing; originally the low room above the small east wing opened from the northerly room in the main house.

A framed grainery stands north of the house; a driveway extends through its ground storey, flanked by narrow corn cribs on either side, beyond each of which is a narrow wagon shed. The broad gable extends over these five elements and a 6/6 window is near its peak. The circular-sawn timber braced frame is joined with pegged mortise and tenon; second floor joists are of logs.

A few ruinous stone walls mark the site of a former bank barn west of the grainery.

Southwest of the house, some distance along a lane, are two tenant houses.

The first, or northerly tenant house is two storeys high, four bays in length with a one-storey shed-roofed wing at its south end; a one-storey shed-roofed porch extends across almost the entire east front. A single-flue brick chimney rises through the gabled roof ridge approximately in the middle of the house and another rises internally at the north gable. A third chimney rises through the southwest corner of the south wing. The southerly half of this tenant house appears to be of log construction and it measures approximately 16 by 20 feet; it stands on a stone foundation, as does the shed-roofed south wing. An entrance is in the southerly bay of the log section and 6/6 windows are in all other bays in both storeys. A secondary entrance is in the northeast corner of the south wing and a 6/6 window is in each of its three exterior sides.

The northerly half of the tenant house is of frame construction on a concrete-block foundation. All exterior walls are covered with sheet material pressed in a brick pattern, painted white.

The second or southerly tenant house is two storeys in height, four bays in length, apparently of frame construction (covered with asbestos shingles) on a stone foundation. A single-flue brick chimney rises from the middle of its gabled roof. Entrances in its principal or east front are in the two middle bays, a 6/6 window is in each of the end bays, in both storeys; the two middle bays are void of openings in the second storey. A window is entered on the gabled ends in each storey. Neither tenant house was examined internally.
