DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Mill house is a two storey frame house, five bays in length, facing south; centered on its principal facade is a roof gable containing a pair of arched 2/2 windows. Extending north, approximately centered, is a two storey frame wing, two bays in length. A one-storey shed-roofed porch extends across the south front and similar porches flank the north wing, the easterly one now enclosed. Exterior walls are covered with German siding. Single-flue brick chimneys rise on either side of the middle bay and a third rises internally at the north end of the rear wing; a modern fireplace chimney is added externally at the west end of the main house. The gabled roofs extend over end walls with bold rake cornices rising from eave returns.

The principal entrance, centered on the south front, has sidelights and a transom. The second storey window above is a pair of narrow 2/2 windows, flanked by wide louvred blinds. Other windows are 2/2, with narrow beaded frames and louvred blinds.

The interior of this house was not examined. Its conjectured construction date is 1890-1905.

Northwest of the house is a one-storey stone outbuilding, three bays in length with a stone chimney rising internally at its west end above its low-pitched roof. Its board door is centered between two small square windows and the building appears to be a dairy house but its interior was not accessible for inspection.
