Constructed between 1850 and 1865, the Galloway House is located in the Tenth District near the Harford County line. The Tenth District is highly agricultural with over 48 square miles within its boundaries. In 1881, it was noted to having a population of 2,374, which was down by 192 since the 1870 census.¹ The district is bounded by Harford County on the east, the Eleventh District on the south, Seventh and Eighth Districts on the west, and Seventh District on the north. It is unclear if this dwelling existed on the 1850 atlas. However, it does show up on the 1877 Hopkins Atlas of Baltimore County. At this time Wilson Road is shown as a dirt road with William Galloway at this particular farm. L.N. Benham with 178 acres is owner of this farm according to the 1915 Bromley Atlas.

This vernacular dwelling is sited in a rural landscape on a sloping grassy lot surrounded by mature and immature trees and foundation plantings. Facing northeast, this wood frame dwelling is two-and-a-half stories high and five bays wide with an L-shaped footprint. Across the full-width of the façade is a half-hipped roof porch supported with Tuscan wood chamfered posts and a square balusters. It has a central passage entrance with a single-leaf 6-panel wood door. Each of the nine windows on the façade are 6/6 double-hung vinyl sash. Rising above the cross-gable roof are three interior-end brick chimneys, two with caps. The roof is clad with standing-seam metal, and features overhanging eaves, with a boxed cornice with returns encased with aluminum. Other features of the house are the entry with the elliptical transom and three-light and dado sidelights. Located on the side elevation, is a one-story wood frame circa 1990s addition. It rests on a poured concrete foundation and has one exterior-end brick shouldered chimney. Associated with this property are four non-historic buildings and one non-historic structure.

This vernacular dwelling is sited in a rural landscape on a sloping grassy lot surrounded by mature and immature trees and foundation plantings. Facing northeast, this wood frame dwelling is two-and-a-half stories high and five bays wide with an L-shaped footprint. Across the full-width of the façade is a half-hipped roof porch supported with Tuscan wood chamfered posts and a square balusters. It has a central passage entrance with a single-leaf 6-panel wood door. Each of the nine windows on the façade are 6/6 double-hung vinyl sash. Rising above the cross-gable roof are three interior-end brick chimneys, two with caps. The roof is clad with standing-seam metal, and features overhanging eaves, with a boxed cornice with returns encased with aluminum. Other features of the house are the entry with the elliptical transom and three-light and dado sidelights. Located on the side elevation, is a one-story wood frame circa 1990s addition. It rests on a poured concrete foundation and has one exterior-end brick shouldered chimney.

Associated with this property are four non-historic buildings and one non-historic structure. First, is a circa 1980 garage, one-story high and two bays wide capped with a side gable roof, and clad with standing-seam metal. Next, is a recently constructed wood frame stable standing one story high and three bays wide capped with a front gable standing-seam metal roof and clad with board-and-batten siding. Next, a board-and-batten barn is capped with a side gable roof clad with corrugated sheet metal. There is a one-story one bay wide wood-frame shed clad with board-and-batten siding. This building rests on a concrete slab and the front gable roof is covered with corrugated sheet metal. Finally, is an in-ground concrete pool sited directly to the rear of the house.


