DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Chesapeake (store)

This building, which has been used as a store, has seen many changes during its history. The two-story frame structure is six closely-spaced bays wide bay five long bays deep. Its shallow gable end faces the street.

The first bay was originally a two-story porch which now has been almost completely enclosed. The first floor, when first enclosed, was covered with wooden shingles. It is now covered with asbestos shingles. Two front doors each have a window to either side. The second floor is enclosed on the ends, with a 6/6 sash window in each end, and enclosed to waist-height along the front. Turned porch posts with scrollwork brackets support the roof.

On the west side, one 6/6 sash window appears on the lower enclosed porch. This window and the adjacent window and door are shaded by a pent-like shed roof, supported by unadorned brackets. Another door and a window follow on the first floor. Four 6/6 windows light the second floor. The building is covered with asbestos shingles.

STATEMENT OF SIGNIFICANCE

Wheatley's store was one of the two "colored" stores operating in E. Towson. Because of discrimination Blacks were not allowed in certain business establishments; therefore it was necessary to create their own. Wheatley's represented a successful attempt to meet the needs and desires of the E. Towson constituency.
