DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Built as a bank early in the Twentieth Century, 50 MAIN STREET is still a bank. Of brick construction (with mid-twentieth century symmetrical flanking wings and an Indiana limestone facade) the central section is the original, a small rectangular structure, its short or gable end to the street, one tall storey in height with a low-pitched gabled roof. Its brick walls, laid in common bond, every sixth course headers, rise above a double ledge water-table. Original windows had jack arches 1½ bricks in height; one, reduced in height, remains in the north wall west of the north wing. In the mid-twentieth century, narrow flat-roofed wings were added on either side and the tripartite street facade was refaced in Indiana limestone recalling eighteenth century English pattern book design. The principal entrance is centered, embellished with a stone architrave, and carved stone consoles supporting a shallow stone pediment. A window is on either side of the entrance in the central (the original) block and a single window is in the front facade of each narrow wing. Shallow panels are above the windows of the central block and that portion of the structure is finished with a stone architrave, frieze, dentiled cornice and finally a stepped parapet in lieu of a pediment.

Internally the entire structure is a single space, the principal banking room being in the original portion with officers' desks in the wings. A small second floor is in the rear or westerly bay of the original section. An access panel opens to space above the present ceiling of the banking room, several feet below the original ceiling, of plaster on circular-sawn lathe fastened with wire nails.

The attic was not accessible for inspection.

A cellar is beneath a small twentieth century one storey addition at the west end of the original structure.

A curved retaining wall with pedestals supporting spheres flank steps -- all of cut limestone -- leading from the street to the front entrance.

STATEMENT OF SIGNIFICANCE

50 MAIN STREET has been a bank since its construction early in the 20th century, at first an independent bank, now with modest but distinctive additions, a branch of a larger system in the metropolitan area. The mid-twentieth century facade and retaining walls flanking the steps at the street were derived from 18th century English pattern books.

This building was built as a bank to serve Reisterstown when it was a small rural community, not a part of the suburbs of a major city, its present position. Remarkably it still serves as a bank, albeit with modest but distinctive additions, built to convey the dignity and solidity of the bank.

In March 1901, several of the town fathers of means decided that a community as vital and forward looking as was Reisterstown could support a bank and make good use of all its services. They formed and incorporated the Reisterstown Savings Bank of Baltimore County. The five original Directors were:

- George W. Albaugh of Carroll County
- Reister Russell School Commissioner for Baltimore County
- Frank H. Zouck Chairman of the States Roads Commission
- Dr. James Gore
- William L. Shriver

This corporation was formed for the purpose of conducting the business of a savings institution and of receiving from any person or persons or bodies corporate, or politic any deposit of money or other securities for loan or investment... (Corporation Records *NBM 4/22*)

The building was built on land acquired from said Reister Russel in 1901 (NBM 255/547 Confirmatory Deed). The building, according to a student paper written shortly afterwards and now in the possession of Mrs. Louise Goodwin of Reisterstown, was "two rooms originally, then they added another room and fixed the front and back."

8. Significance, continued

In 1952, there was a merger between the Reisterstown Savings Bank and the Glyndon Bank (State Tax Commission Charter Records 386/97)

In June 1953, more acreage was added. This was conveyed to the bank by Carroll Saumenig and wife, Helen (GLB 2307/314).

In June 1958 the Reisterstown-Glyndon Bank deeded all its acreage and merged with Union Trust Bank (3441/395).
