DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Washington Ave. is a brick gable roof house comprised of different wings and additions with various storey levels. The west facade is characterised by a two storey plus attic center block and a wing on each of its corners. It is capped by a gable roof which has deep eaves that give the suggestion of a pediment. The first storey of this block is 5 bays wide and seems to be an enclosed porch with a $\frac{1}{2}$ hipped roof that separates it from the second storey. The north and south facades of this enclosure each have 2 $\frac{6}{6}$ light casement windows. The half glass half wood door has a glass transom, one sidelight and occupies the southmost bay. The 4 remaining bays northward have $\frac{6}{6}$ lights casement windows. The two bays in the second storey and attic have $\frac{8}{1}$ light windows.

The south two storey brick wing which is attached to the west facade's center block has a wood door in the south bay that has 4 lights and is topped by a flat arch. There is a $\frac{4}{4}$ light casement window in the north bay of the second storey.

The one storey wing to the north of the center block has a half hipped roof and a door with a $\frac{4}{4}$ light transom. This wing has an arched window in the center bay with two rows of header bricks as lintels in the north facade.

The north facade of the main block has an 1/air conditioner window in the east bay of the first storey and 2 $\frac{8}{1}$ windows in the east and west bays of the second storey which surround an outside end chimney. To the northeast of the chimney sit 2 dormers. The 2 storey east end of this facade extends outward with one $\frac{8}{8}$ light window in each storey.

In between the south facade of the one storey (west facade) enclosure and partially covered by the corner of the south facade of the main block is an $\frac{8}{1}$ light window in the first storey. This side of the house shows a flat roof. In the west bay of the basement there is a wood door with a flat arch and a 3 light casement window in the middle and east bays. The first storey has a double hung $\frac{2}{2}$ light window in the west bay and a recessed arch entrance to its right (east) which has a double row of arched headers above it; the second row is raised. There is a wood door housed in this entrance. Going easterly there are 4 $\frac{8}{1}$ light windows that become progressively longer as they move east. There is a $\frac{4}{4}$ light casement window in the west bay and 4 $\frac{8}{1}$ light windows in the remaining eastern bays of the second storey.

The east facade is characterised by various roof lines which reveals a gable roof and shingled facade behind parts of the brick facade which seem to be (possibly) part of the original frame house. The south brick projection is two stories high with an $\frac{8}{1}$ light window in the center bay of each storey. The building wall then reduces to one storey moving north, which is 2 bays wide and has an $\frac{8}{1}$ light window in both bays.

Behind the brick facades is a 2 storey frame facade that is covered by what appear to be asbestos shingles. The first and second stories of this block, which are separated by a wood railed sun porch each have one $\frac{8}{1}$ light window. There is a door in the south bay and an $\frac{8}{1}$ light window in the north bay of the gable.

A north two storey one bay wide brick wing is attached to the building at the north end of the east facade. It has a half glass half wood door in the first storey that is covered by a shed roof entrance and an 8/8 light window in the second storey. There is a small double hung 3/3 light window that faces north on of this facade placed at a level slightly higher than that of the top of the door.

All of the house's windows and doors except for those in the wood part have flat arch lintels and brick sills. There is a decorative belt course of verticle stretcher bricks that goes around the house about 12 inches from the ground.


