DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Two stone cottages stand side by side on the west side of Cedar Avenue and have a similar vernacular design.

This two story structure has fieldstone walls covered with brown stucco and is topped with a gable-end roof. It measures two bays wide, a larger two bays deep and has an uneven fenestration.

The east facade is the main facade. A replacement porch covers the entire first level. The owner remembers, however, that there was a "front and back" stoop. The south bay contains a pair of 2/2 sash windows which share a common lintel. The door in the north bay has a 6 light transom. The second level is a regular 6/6 sash.

The first story of the north facade is blocked by a shed roofed single car frame garage which has vertical tongue and groove doors. On the second level, the east bay is blind but the west has one 6/6 sash window.

The windowless south facade has an interior end chimney that is corbeled and capped and appears to be the size of a flue chimney. It is possible that this facade has been altered.

There is a single story frame kitchen addition on the west facade.

Interior access was not gained.


