DUNLOP HOUSE/ METHODIST PARSONAGE

1831

MARYLAND LINE

PRIVATE

The present Methodist parsonage is log under its aluminum siding, a vernacular style, two-story house with full width front porch and rear wing. It can be traced back to lots acquired by John and Susannah Dunlop in 1830 and 1831 for \$46. By 1832, the Dunlops sold to Michael Gipe for \$300, which would indicate completion of a modest house. The house was advertised under decree in the American in 1834 and passed to the Crout or Krout family, then to William Sykes (1856) and to Robert Caskey (1867). In 1894, the trustees of the Methodist Protestant Parsonage purchased the house. In 1926-1927, a new Methodist Church was built on the lot to the south.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Dunlop House, now serving as a parsonage, is a small vernacular house of two stories. Its main block is a log and chink structure, completely disguised by improvements, including an outer covering of cream-colored aluminum siding. The house is close to the public highway, its porch four steps above grade. The house is four bays wide the door located in the third bay from the south (or left), producing a side-hall plan. All front windows are 6-over-6 double-hung sash types. The porch is full width, hip-roofed, supported by five wrought iron columns with decorative scrolls. The porch has an architrave and an overhanging soffit. There is also a wrought iron porch railing and hand rails along the steps. The roof is gabled and overhangs slightly on the ends; its soffit, now covered with aluminum trim material, projects about a foot beyond the house wall. There is an inside end chimney at the north end of the house. The main block of the house is two bays deep with two, 1-over-1 windows at each story; the gable ends contain two square attic windows, each with a single window light.

A gable-roofed rear wing two bays deep is attached to the main block. The wing is the same width as the main block. On its south facade, this wing contains at first story level (1) a double-hung sash window of 6-over-6 format, (2) one small rear window with a metal frame, of 1-over-1 format. At second-story level there are two bays, each containing a 6-over-6 double-hung sash window.

On the north facade of the rear wing, there are two bays, each of the four positions filled with 6-over-6 sash windows.

A one-story shed roof extension at the rear of the wing has no windows on its north surface, one small window of 1-over-1 format in the south facade.

The entire house is covered with aluminum siding of a cream of caramel color. Foundation is stone. The house has a smart, fresh appearance.

SPECIFIC DATES 1831 BUILDER/ARCHITECT

STATEMENT OF SIGNIFICANCE

The present Methodist Parsonage can be traced back to two 40-square perch lots acquired by John Dunlop from John Lowe and John Walker in 1830 and 1831 for \$21 and \$25, each, respectively. (1) In 1832, John and Susannah Dunlap sold the 80 square perches to Michael Gipe for \$300, which would allow for a decent house to have been added, probably in the building season of 1831. (2)

The 1833 Assessor's Field Book showed Michael Gipe with a total of 4 acres and \$250 in improvements, two cows, and six hogs. (3)

However, in September 1834, the Constable, Jacob B. Wilhelm served a writ of Fieri Facias on Michael Gipe, and the property was advertised in the Baltimore papers:

Lot 1. Contains about 80 square perches, more or less with the following improvements on it-- a good log house and kitchen, oven, Barn, Wagoners Shop, pump &c., adjoining the lands of George Bond, Solomon Cox, and others.... (4)

Constable Wilhelm conveyed to Michael Crout in October 1835 for \$405; the tract name was "Sparks Folly Resurveyed." (5) The property came to Adam H. Crout on the death of Michael Krout (previously spelled "Crout") in 1849. Adam H. Krout sold to William Sykes in 1856 for \$800. (6)

William Sykes sold this lot and one of 58 square perches to Robert Caskey in 1867. (7) The Caskey house was shown in the 1877 atlas. John F. Caskey, executor of Robert Caskey, sold to Elizabeth Sykes in 1890 for \$1,050 and Elizabeth Sykes promptly deeded back to Caskey as an individual for the same price. (8) Four years later, Caskey sold the property to a group of local residents who served as Trustees of the Methodist Protestant Parsonage of the New Market Circle of the Methodist Protestant Church for \$1,250. (9) Caskey allowed the parsonage property to enjoy the use of his well for a two-year period.

The parsonage property was recorded in 1962 to reflect the fact that in 1914 the church body was incorporated, and still later merged (in 1939) with the town's other Methodist group and the charter amended. (10)

In 1977, the Maryland Line church body became sole owners of the parsonage, having acquired the collective interests held in the house by the congregations of Bentley Springs U.M. Church, Mt. Zion U.M. Church, and Oakland U.M. Church. (12).


