This 1½-story wood frame Dutch Colonial Revival house is constructed on a concrete wall foundation and measures three bays by two bays. The house has a gable roof stoop and gable dormers. The gambrel roof is clad by composition shingles and the building is clad by vinyl siding. Additions include an enclosed rear shed roof porch and a porch addition to the north side.

The house was built between 1930 and 1940 by the Leight Brothers for owner Charles Martin. A common early twentieth century house type, there are no significant distinguishing features in this building and its original fabric has been changed by additions and alterations. This property appears to be not eligible for listing in the National Register of Historic Places.



The Martin house is a well designed colonial revival cottage built prior to World War II, probably in or before 1940. It was first owned by Mrs. Golda Martin. There is a centrally located entrance sheltered by a shallow pedimented portico. The portico roof is supported by contemporary wrought iron grillwork sections. The house is frame, gambrel-roofed, and covered with white aluminum siding. Set well back from the highway on a slope the cottage is a visual asset to the town. Until 1980, it was screened behind a thick hedge.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Martin House is a small colonial revival structure set well back from the street on a gentle slope. After its hedge was removed in 1980, the lines of the house became visible. It is a 1½-story cottage with a gambrel roof and two gabled dormers. The main story is three bays wide with a glass and frame door in the center. The entrance is sheltered by a small pedimented portico that is supported by wrought-iron grillwork columns. The porch deck is a small platform two steps above grade. The center door contains six square window lights. The pediment is decorated with a metal American Eagle.

Main-floor windows are aluminum-framed sash windows in 1-over-1 layout. These two windows are flanked by louvered shutters.

There is an open side porch with a shed roof at the right-hand (or north) end of the house. The two dormers facing the road are fitted with double-hung sash windows of 6-over-1 layout.

The ends of the house are two bays deep at ground floor level, with single windows at the gambrel roof peak. A small square brick chimney emerges in the center of the house through the ridge line. The outer walls are sheathed with a white aluminum siding. The roofing material is a bluish rubber material. The foundation is apparently of stone.

STATEMENT OF SIGNIFICANCE

The Martin House is almost too young to take note of, but after its obscuring hedge was removed in mid-1980, it became a visual asset to the north end of town. It is a traditional house that is not found in the 1928-1940 tax ledger, but appears in the original entries of the 1940-1946 tax ledger. (1) The first owner was Golda Martin, and the house was valued at \$800. A handwritten correction made to the same page in the Martin tax account, shows that in 1946 it was transferred to the account of Harvey M. Martin. The transfer had taken place in 1945, Mrs. Golda Martin having been divorced and taken a new name, Golda I. Light. (2)

Charles Webster Martin acquired a half interest in 1945 and in 1954, along with Frances Ruth Martin, became owner of the entire property. (3, 4)


