Large stone house overlooking Loch Raven, built for William G. Baker, Jr., of Baker-Watts brokerage house. Assisted at \$70,000 when added to the tax ledger as "New 1931". House was visited by the national convention of Garden Club of America in May 1940. The club guide book described the gardens as laid out on the floor plan of Chartres Cathedral.
