Standing alone in the field near the present farmhouse is a four-bay, one-story frame building in poor condition. The building has remained in the Todd family from the beginning but has seen the last of human habitation. It is a two-room building, the product of two building periods. The earliest portion has exposed joists and a stair enclosed behind some board paneling. Its fireplace has the back exposed on the exterior and on the side opposite the stair is a crude glazed cabinet. Apparently the loft was never finished as there are no signs of there having been plaster. This is an unusual survivor of a farm dwelling which was common on poorer Eastern Shore farms.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The James Todd House is located on a dirt land leading south from Chipman's Road, approximately one mile west of its intersection with the Smithville Road in the vicinity of Smithville, Caroline County. The early nineteenth century structure is in a ruinous condition.

A one story frame structure, the house consists of two section built at different times and which both have a regular size clapboard sheathing. Both sections are one room in size and the east section, which has a single 6/6 sash window on the north and south facades, was built onto the west section, which has an entrance and 6/6 sash window on the north and south facade. Stuccoed brick chimney stacks rise from the ridge at both ends inside the steep gable roof. Both gable ends have four pane casements in the gable and the west elevation has an exposed back wall of the fireplace.

The interior has hewn exposed beams and plaster walls. The west fireplace wall contains an enclosed corner staircase and a glazed cabinet within the vertical beaded boards. Batten doors are hung from the fireplace jamb to "close off" the large opening.

STATEMENT OF SIGNIFICANCE

The James Todd House is a good example of the scale and living conditions found in the domestic architecture of early nineteenth century Caroline County. These small frame structures were probably the most common of the early farmhouses, but because of their size, building material, and changing architectural tastes, very few remain in the region.


