Circa 1800

This building was moved from its original site when the present dwelling was constructed at the end of the last century. The old building lost its roof structure in a fire in the 1960's, but the plan is apparent, as well as some of the features which are typical to lower Caroline County. It had two center doors, like Genesar, Worcester County, a "hall and parlor" plan, and exposed beaded joists and beaded board dado. It was similar to the building at Painters Range.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Goswellen Building is located on Newton Road, approximately one-half mile from Maryland Route 331, north of Preston, Caroline County. The building is an early nineteenth century house that was partially destroyed by a fire in the 1960's. The roof was replaced with a low pitched tin roof and in 1977, aluminum was applied to the exterior. It's current use is for storage of farm tools and supplies.

The house was moved from its original foundation in the late nineteenth century when a Victorian style house was erected on the site. The new site for the Goswellen Building was slightly southeast of the new house. Originally, the Goswellen Building was one and one-half stories, four bays long with a two room plan. The frame structure was clapboard and had batten doors on the two inner bays, and 6/6 pane windows in the outer bays of the main facade. One of the doors has been covered with aluminum siding, and the other facades have been altered.

The fire burned the garrett of the house. The interior still contains the corner stairway, beaded ceiling joists that were once painted blue, and beaded horizontal board dado.
