This mill house is a good example of late 19th century architecture combined with a small portion of an earlier building. The porch in this case, and in many instances in this period, appears more decorative than any of the interior. It appears to have been the product of two or three major building periods and was influenced by the chimney design of Memory Lane across the road.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Williston Mill House is a substantial frame dwelling which appears to date from the late 19th century. On closer examination, however, the three westernmost bays appear to date from around the 1840-60 period while the porch appears to be 1870's and the back extension and eastern bay appear to date from the 1890's. The two story frame building has a 'T' plan with porch on the front and both sides. It now consists of a central stair hall with room on each side and two rooms in the leg of the 'T' (originally three).

German siding covers the building while there is imbricated shingle in the gables. The windows have 2/2 sash and louvered shutters with wide trim having a molding only over the lintel. On the apex of the 'A' roof at the west gable, rises a brick chimney with paneled insets like Memory Lane, across the road. Another chimney rises from the center of the wing and a third chimney formerly rose from the juncture of the two front sections. Directly behind the top of the 'T' are two small light rooms which have nearly flat roofs behind a shingle parapet.

The two porches have different scrolls and pendants than the front porch which is the product of two stages of building.

Between the house and road is a white board fence. Down the hill in back of the house stands the old grist mill which formerly was operated by the owner of this house.

STATEMENT OF SIGNIFICANCE

Between 1894-1931 the mill was owned and operated by Willard C. Todd. He overtook the renovation of the old mill and house after his acquisition of the property in 1894 and what we see in the house and mill is largely due to his work.

Potters Mill was owned by S. Fountain Liden after 1867. Beside the mill and house there were also mentioned in the deed a saw mill and millpond. He owned the property until his death around 1880, after which time it was purchased by Frederick Lyden, undoubtedly a relative.

Prior to 1867 the property was owned by Thomas Garey who also owned and operated a mill at Garland Lake which was originally owned by Matthew Driver, owner of Willow Grove.

Evidently this mill was owned and operated in the early 19th century by the man who built Potter Hall.

This mill house is a good example of late 19th century architecture, when the porch was frequently the most elaborate feature of the house. It is of interest that the building was a product of at least two major stages of building and it is also of interest that it was influenced by the more elegant country house, Memory Lane.


