STATEMENT OF SIGNIFICANCE

This site is of interest as the place where a notorious outlaw lived in the pre-Civil War days of slavery. Patty Cannon and companions made a profitable living from stealing slaves and free blacks and selling them into slavery in the south.

There is a claim in Dorchester County that Patty Cannon's house is located at the intersection of Route 577 and 392, however, this does not coincide with accounts that parts of her house were located in both Maryland and Delaware. It was Joe Johnson's Tavern.


