DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Reick House is located on the west side of Payne Road, approximately one-half mile south of Kraft Road, northeast of Preston, Caroline County. A structure that differs from the representative farmhouse form, the house appears to be mid-nineteenth century in build.

The house is two storys with a hipped roof, rectangular plan, and five bay main facade (east elevation). The exterior of the house is stucco and there is a full length, one story porch supported by broad stuccoed posts. The main facade has a central entrance with a transom, and 6/6 sash windows with black louvered shutters are in the other bays. There is a tall brick chimney stack interior end of the south wall, and another stack on the west wall towards the north end. There is a small ell wing on the north side of the west wall.

STATEMENT OF SIGNIFICANCE

The Reick House, with its hipped roof and stuccoed exterior wall, represents a different style influence than normally found in Caroline County. The broad low proportions of the house and scarcity of ornamentation give the house the appearance of an early villa style of architecture.


