## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Wrotten House is located in the village of Linchester a short distance southeast of Preston. It is located on the northeast side of the old main road across from Richard Gadow's house. In form the dwelling most resembles the Schmick House across the street, with two one and one-half story cells adjoining. Unlike the Schmick House, this building has a leanto addition across its back facade rather than a third section.

The tallest part of the building is three bays long with central entrance and a single dormer on the 'A' roof. The other section is shorter and slightly smaller and lacks the entrance, but otherwise is the same. Both sections have chimneys, one within the northwest gable and one on the outside of the southeast gable. Aluminum siding covers its walls and the windows also are flanked by aluminum shutters. Old 6/6 pane sash remain in all windows. The entire building is constructed upon birck piers.

Judging from the wide corner posts and their general similarity to the Schmick House, the building appears to date from the first half of the 19th century, although a portion may pre-date that period. Future investigation will reveal this information.




