The Denton Hardware Company is housed in a c. 1920 one story three bay side flat roofed structure built of coarse faced concrete block. Possessing more decorative features than most other commercial buildings on this block, it has four small pedestals with knob-like finials which extend above the facade roofline and a top course of beaded concrete. A thin wooden cornice runs above the first story and there is a double door entrance which is recessed within display windows with multi-paned transom lights.




