Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

This gable roofed house built on a T-plan is the only one of brick construction in the district and probably dates from c. 1910. The facade gable has a heavy cornice and is finished with small fish scale shaped tiles with embossed design; the gable window has a segmental arched architrave.

The porch wraps around three sides of the house and is supported by short Tuscan columns on brick piers.




