This two and one half story three bay wide house has a hip roof with a Chippendale balustrade along the ridge and two pedimented roof dormers with 6/6 sash lights in round arches with pilasters.

The entrance is flanked by bay windows and has a projecting pediment over a semi-circular arch, laurel wreath decoration and a dentilled cornice over the four-panel double doors. Fluted pilasters flank the entrance and Tuscan columns support the pediment.

Both porches on the north and south elevation have flat roofs with Chinese Chippendale balustrades, dentilled entablatures and Tuscan columns.


